1 (11)(10) "Provisional employee" means a person who has been 2 appointed to fill a position pending the establishment of a register for such 3 position; 4 (12) "Severe illness" means a medical condition of an employee 5 or an employee's immediate family member: 6 (A) Which is catastrophic in nature; 7 (B) Which could not be anticipated; 8 (C) That requires continuous in-patient or out-patient 9 medical treatment: and 10 (D) That causes an employee or the employee's immediate 11 family member to be absent from duty for a prolonged period of time; 12 (13) "Shared leave" means the donation of an employee's earned 13 sick leave or earned annual leave to another employee who: 14 (A) Is suffering from a severe illness; 15 (B) Has an immediate family member suffering from a severe 16 illness; or 17 (C) Has approved paternity leave or approved maternity 18 leave after: 19 (i) The birth of a biological child; 20 (ii) The placement of an adoptive child in the 21 adoptive home of the employee; or 22 (iii) The placement of a foster child in the foster 23 home of the employee for an appropriate transition period that is in the best interest of the foster child as determined by the Division of Children and 24 25 Family Services of the Department of Human Services; 26 27 SECTION 3. Arkansas Code § 21-4-209 is amended to read as follows: 28 21-4-209. Maternity leave. 29 (a) Maternity leave shall be treated as any other leave for sickness or disability. Accumulated sick leave and annual leave, if requested by the 30 31 employee, shall be granted for maternity use, after which leave without pay may be used. 32 (b) Catastrophic leave under § 21-4-214 may be used for maternity 33 34 leave. 35 36 SECTION 4. Arkansas Code § 21-4-214 is amended to read as follows:

2	(a)(1) The Department of Finance and Administration shall have
3	administrative responsibility for developing, implementing, and maintaining a
4	the statewide catastrophic leave bank program.
5	(2) <u>(A)</u> Each state agency approved by the department to
6	participate in the catastrophic leave bank program may establish a
7	catastrophic leave bank for its employees, or the state agency may shall
8	participate in a catastrophic leave bank to be administered by the Office of
9	Personnel Management of the Division of Management Services of the Department
10	of Finance and Administration.
11	(B) The following governmental entities may voluntarily
12	participate in the catastrophic leave bank program or establish a
13	catastrophic leave bank for its employees:
14	(i) The General Assembly;
15	(ii) The Bureau of Legislative Research;
16	(iii) Arkansas Legislative Audit;
17	(iv) The Arkansas State Highway and Transportation
18	Department;
19	(v) The Arkansas State Game and Fish Commission;
20	(vi) The Supreme Court;
21	(vii) The Court of Appeals;
22	(viii) The administrative offices of the courts; and
23	(ix) A constitutional office.
24	(b) Accrued annual leave and sick leave of employees may be donated to
25	a catastrophic leave bank.
26	(c) Catastrophic leave with pay may be granted to an employee when the
27	employee is unable to perform his or her duties due to a catastrophic
28	illness, including maternity purposes.
29	(d) An employee may be eligible for catastrophic leave when:
30	(1)(A) The employee has been employed by the state for more than
31	two (2) years <u>one (1) year</u> or was previously employed by a public school
32	district or state-supported institution of higher learning for more than two
33	(2) years.
34	(B) A person who was employed by a public school district
35	or state-supported institution of higher learning for less than two (2) years
36	one (1) year also is eligible for catastrophic leave if:

1 (i) The person's combined years of employment with 2 the state and with a public school district or state-supported institution of 3 higher learning totals more than two (2) years one (1) year; and 4 (ii) The lapse in the person's employment between 5 the state and a public school district or state-supported institution of 6 higher learning is less than six (6) months; 7 (2) Catastrophic leave for maternity purposes may be granted to 8 a female employee after: 9 (A) The birth of the employee's biological child; or 10 (B) The placement of an adoptive child in the home of the 11 employee. 12 $\frac{(2)(A)}{(3)}(A)$ At the onset of the illness or injury the employee had to his or her credit at least eighty (80) hours of combined sick and 13 14 annual leave and has exhausted all such leave, unless the combined sick and 15 annual leave requirement is waived under subdivision (d)(2)(B) of this 16 section. 17 (B) A state agency director or a president of an 18 institution of higher education may waive the minimum eighty-hour requirement 19 for combined sick and annual leave if the agency director determines that the 20 employee warrants eligibility because of extraordinary circumstances under 21 the standards and guidelines promulgated under subdivision (f)(2) of this 22 section; 23 (C)(i) An employee on catastrophic leave for maternity 24 purposes is not required to exhaust sick or annual leave before being granted 25 catastrophic leave. 26 (ii) An employee on catastrophic leave for maternity purposes 27 does not accrue any leave. 28 (3) (4) An acceptable medical certificate from a physician 29 supporting the continued absence is on file; and 30 (4) (5) The employee has not been disciplined for any leave abuse 31 during the past two (2) years year from the time of application. 32 (e)(1) Up to four (4) consecutive weeks of catastrophic leave with 33 full pay may be granted to an employee for maternity purposes. 34 (2) The employee shall be eligible for the leave only within the 35 first twelve (12) weeks after the birth or adoption of a child. (3) After the expiration of the four (4) weeks of leave under 36

Shared leave - Definition. 21 22 (a) As used in this section, "employee" means a person regularly 23 appointed or employed in a position of state service by a governmental entity listed in subdivision (b)(1) of this section for which he or she is 24 25 compensated on a full-time basis. 26 (b) An employee is eligible to obtain shared leave if the employee 27 has: 28 (1) Been continuously employed for more than one (1) year by 29 the: 30 (A) Same state agency; 31 (B) General Assembly; 32 (C) Bureau of Legislative Research; 33 (D) Arkansas Legislative Audit; or 34 (E) Arkansas State Highway and Transportation Department; (2) Applied in writing for shared leave; and 35 36 (3) Received written approval for shared leave from his or her

2	(c) If shared leave is granted to an employee under this section, the
3	employee shall use the shared leave after the employee uses the following:
4	(1) Earned sick leave;
5	(2) Earned annual leave; and
6	(3) Earned compensatory leave.
7	(d)(1) An employee is eligible as a donor of shared leave when the
8	employee:
9	(A) Is employed by the same employer as the employee
10	receiving shared leave;
11	(B) Has cumulative earned sick leave and earned annual
12	leave in excess of eighty (80) hours; and
13	(C) Has not been disciplined by a governmental entity
14	listed in subdivision (b)(l) of this section for an abuse of leave in the
15	past two (2) calendar years.
16	(2) A donation of leave as shared leave must be approved in
17	writing by the:
18	(A) Donating employee's employer; and
19	(B)(i) Chief Fiscal Officer of the State.
20	(ii) The Chief Fiscal Officer of the State shall
21	determine whether the employer of the employee who would donate shared leave
22	has sufficient funds in its budget to grant the shared leave.
23	(3) An employee donating shared leave may donate only the amount
24	of earned sick leave or earned annual leave that will not cause the donating
25	employee's cumulative earned sick leave and earned annual leave to be less
26	than eighty (80) hours.
27	(4) An employee may receive a maximum of two thousand eighty
28	(2,080) hours of combined shared leave and catastrophic leave in a calendar
29	year.
30	(e) An employee who is granted shared leave shall provide his or her
31	employer:
32	(1) An acceptable medical certificate from a healthcare provider
33	documenting the severe illness or the birth of the employee's biological
34	child that made the employee eligible for shared leave;
35	(2) A final decree of adoption issued by a court of competent
36	jurisdiction approving the adoption of a child by an employee; or

1	(3) Documentation provided by the Division of Children and
2	Family Services of the Department of Human Services approving the placement
3	of a foster child in the foster home of the employee.
4	(f) Shared leave that is donated to an employee and is not used by the
5	employee shall be converted to the catastrophic leave program as described
6	under § 21-4-214.
7	(g) The Office of Personnel Management of the Division of Management
8	Services of the Department of Finance and Administration shall establish
9	procedures and guidelines to implement this section.
