22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Arkansas Code Title 27, Chapter 51, Subchapter 15, is
25	amended to add an additional section to read as follows:
26	27-51-1507. Additional Penalties - Collision or accident.
27	If a person pleads guilty or nolo contendere to or the finder of fact
28	determines that the person was involved in a collision or accident resulting
29	in property damage, physical injury or death to a person while in violation
30	of this subchapter, a court may in addition to any other sentence assess an
31	additional fine of:
32	(1) No less than one hundred fifty dollars (\$150) and no more
33	than one thousand dollars (\$1,000) for the first offense;
34	(2) No less than four hundred dollars (\$400) and no more than
35	three thousand dollars (\$3,000) for the second offense occurring within five
36	(5) years of the first offense; and

1	(3) No less than nine hundred dollars (\$900) and no more than
2	five thousand dollars (\$5,000) for the third or subsequent offense occurring
3	within five (5) years of the first offense.
4	
5	SECTION 2. Arkansas Code § 27-51-1607(a)(1), concerning the penalties
6	for distracted driving, is amended to read as follows:
7	(a)(l) Except for a person involved in a collision or accident under §
8	27-51-1611 For a first offense under this subchapter, a person shall be
9	issued a citation that is a warning citation, and no court appearance is
10	required and no penalty shall be imposed by the court for a first offense
11	under this subchapter.
12	
13	SECTION 3. Arkansas Code Title 27, Chapter 51, Subchapter 16, is
14	amended to add an additional section to read as follows:
15	27-51-1611. Additional Penalties — Collision or accident.
16	If a person pleads guilty or nolo contendere to or the finder of fact
17	determines that the person was involved in a collision or accident resulting
18	in property damage, physical injury or death to a person while in violation
19	of this subchapter, a court may in addition to any other sentence assess an
20	additional fine of:
21	(1) No less than one hundred fifty dollars (\$150) and no more
