18	SECTION 2. Arkansas Code § 6-17-428, concerning ethical violations by		
19	educators, is amended to add an additional subsection to read as follows:		
20	(r)(1) An educator whose license has been revoked may petition the		
21	State Board of Education for reinstatement of the license after the greater		
22	<u>of:</u>		
23	(A) One (1) year from the date of revocation; or		
24	(B) One-half $(1/2)$ of the time for the revocation has		
25	lapsed.		
26	(2) The petition for reinstatement may include the following		
27	information:		
28	(A) A personal statement addressing the educator's		
29	rehabilitation and the misconduct that led to the revocation;		
30	(B) Evidence of rehabilitation, including without		
31	limitation:		
32	(i) Progress reports if enrolled in a rehabilitation		
33	program; or		
34	(ii) Verification of completion of a rehabilitation		
35	<pre>program;</pre>		
36	(C) Character or reference letters;		

1	(D) Work history since the revocation, including the names		
2	of employers and type of work performed;		
3	(E) Any civic activities engaged in following the		
4	revocation;		
5	(F) Any court documents indicating the reduction or		
6	dismissal of criminal convictions; or		
7	(G) Other evidence demonstrating that the educator does not		
8	pose a threat to the health or safety of school children or school personnel.		
9	(3) After conducting a hearing on the reinstatement, the state		
10	board may reinstate the educator's license if the state board determines that		
11	the educator:		
12	(A) Has been rehabilitated and is fit to perform the		
13	duties authorized by the license; and		
14	(B) Does not pose a threat to the health or safety of		
15	school children or school personnel.
