25	SECTION 1. Arka	ansas Code § 23-115-103(22), conc	erning the definition
26	of "operating expenses	s", is amended to add an addition	al subdivision to read
27	as follows:		
28	<u>(M)</u>	Management fees charged by a fi	nancial institution to
29	manage a trust account or fund maintained by the Department of Higher		
30	Education or the office.

32	SECTION 2. Arka	ansas Code § 23-115-801(b), conce	rning the transfer of
33	funds, is amended to read as follows:		
34	(b)(1) $\underline{(A)}$ On or before the fifteenth day of each month, the office		
35	shall deposit the net proceeds from the lottery into one (1) or more trust		
36	accounts at one (1) or more financial institutions.		

1	(B)(i) The office shall establish a trust account for		
2	scholarship award supplements in a financial institution into which the		
3	office shall transfer:		
4	(a) Excess funding returned to the office		
5	under subdivision § 6-85-212(e)(2)(B)(i) from the previous academic year; and		
6	(b) Net proceeds remaining from the previous		
7	academic year after the office:		
8	(1) Transfers under subdivision (c)(2)		
9	of this section the funds requested by the Department of Higher Education;		
10	<u>and</u>		
11	(2) Deposits the amount necessary into		
12	the Scholarship Shortfall Reserve Trust Account under § 23-115-802 to		
13	maintain an amount equal to twenty million dollars (\$20,000,000).		
14	(ii) The funds transferred by the office into the		
15	trust account for scholarship award supplements established under subdivision		
16	(b)(1)(B)(i) of this section shall be used for:		
17	(a) Scholarship award supplements; and		
18	(b) Any management fees charged by the		
19	financial institution to manage the trust account for scholarship award		
20	supplements.		
21	(iii) Annually, the office shall transfer to the		
22	Department of Higher Education the funds from the previous academic year, if		
23	any, that were transferred by the office into the trust account for		
24	scholarship award supplements under subdivision (b)(1)(B)(i) of this section		
25	if any, for distribution as scholarship award supplements.		
26	(2) The office shall follow the investment policy guidelines of		
27	the State Board of Finance in selecting a financial institution and managing		
28	the net proceeds from the lottery deposited into a the trust account		
29	accounts.
