19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

SECTION 1. APPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO.

21 There is hereby appropriated, to the Arkansas State University, to be payable
22 from the General Improvement Fund or its successor fund or fund accounts, the
23 following:

25 (A) for construction, renovation, maintenance, equipment, personal
26 services and operating expenses of the various institutions and entities of
27 the Arkansas State University System, in a sum not to exceed
28\$15,000,000.

29 (B) for construction of a College of Engineering building, in a sum not
30 to exceed.....\$4,000,000.

31 (C) for College of Education and Communications restrooms renovation,
32 in a sum not to exceed.....\$908,500.

33 (D) for Library HVAC system renovation and modernization, in a sum not
34 to exceed.....\$2,000,000.

35 (E) for Lab Sciences Lab and HVAC System renovation and modernization,
36 in a sum not to exceed.....\$1,291,500.



- 1 (F) for critical maintenance, in a sum not to exceed.....\$1,840,000.
- 2 (G) for deferred maintenance, in a sum not to exceed.....\$4,940,000.
- 3 (H) for the purchase, replacement, and renewal of equipment and library
- 4 holdings, in a sum not to exceed.....\$2,342,774.

- 19 building on the Ozark Campus, in a sum not to exceed.....\$120,589.
- 20 (F) for critical maintenance, in a sum not to exceed.....\$300,000.

- 22 exceed.....\$30,000.
- 23 (H) for deferred maintenance, in a sum not to exceed.....\$2,460,000.

10 SECTION 4. APPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is
11 hereby appropriated, to the Southern Arkansas University, to be payable from
12 the General Improvement Fund or its successor fund or fund accounts, the
13 following:

14 (A) for construction of an Educational building, in a sum not to exceed
15\$1,350,000.

16 (B) for technology infrastructure improvements and upgrades, in a sum
17 not to exceed.....\$3,465,750.

18 (C) for renovation of Childs Hall and ADA upgrades to create the
19 Science, Technology, Engineering and Mathematics training center, in a sum
20 not to exceed.....\$2,384,250.

21 (D) for critical maintenance, in a sum not to exceed.....\$420,000.

22 (E) for deferred maintenance, in a sum not to exceed.....\$1,780,000.

23 (F) for the purchase, replacement, and renewal of equipment and library
24 holdings, in a sum not to exceed.....\$618,586.

25

26 SECTION 5. APPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES.
27 There is hereby appropriated, to the University of Arkansas for Medical
28 Sciences, to be payable from the General Improvement Fund or its successor
29 fund or fund accounts, the following:

30 (A) for upgrades to the Central Building to meet code requirements, in
31 a sum not to exceed.....\$4,200,000.

32 (B) for expansion of the Electronic Health System to Primary Care
33 Clinics managed by UAMS Regional Programs and Specialty Clinics operating at
34 the UAMS Northwest Campus, in a sum not to exceed.....\$2,000,000.

35 (C) for the purchase of new and replacement hospital clinical
36 equipment, in a sum not to exceed.....\$1,000,000.

- 1 (D) for construction of an energy plant on the Little Rock campus, in a
- 2 sum not to exceed.....\$1,000,000.
- 3 (E) for critical maintenance, in a sum not to exceed.....\$2,030,000.
- 4 (F) for deferred maintenance, in a sum not to exceed....\$10,730,000.
- 5 (G) for the purchase, replacement, and renewal of equipment and library
- 6 holdings, in a sum not to exceed.....\$1,927,257.

8 SECTION 6. APPROPRIATION - UNIVERSITY OF ARKANSAS. There is hereby

9 appropriated, to the University of Arkansas, to be payable from the General

10 Improvement Fund or its successor fund or fund accounts, the following:

- 16 (C) for technology and equipment upgrades at the Clinton School, in a
- 17 sum not to exceed.....\$75,000.
- 18 (D) for forensic lab and classroom equipment upgrades at the Criminal
- 19 Justice Institute, in a sum not to exceed.....\$103,700.
- 20 (E) for upgrades and renovations to the Agricultural Research and
- 21 Extension Centers and Stations of the Division of Agriculture, in a sum not

9 for the ASMSA, in a sum not to exceed.....\$525,000.

10 (O) for technology and equipment upgrades at the Criminal Justice
11 Institute, in a sum not to exceed.....\$240,000.

12 (P) for deferred maintenance of the Arkansas Archeological Survey, in a
13 sum not to exceed.....\$80,000.

14 (Q) for critical maintenance at the U of A - System, in a sum not to
15 exceed.....\$10,000.

16 (R) for costs of constructing and equipping a Rice Innovation Center of
17 the Division of Agriculture, in a sum not to exceed.....\$1,000,000.

18 (S) for critical maintenance for the U of A - Division of Agriculture,
19 in a sum not to exceed.....\$70,000.

20 (T) for costs of renovation of the Fine Arts Center, in a sum not to
21 exceed.....\$1,200,000.

22 (U) for critical maintenance for the U of A - Fayetteville, in a sum
23 not to exceed.....\$3,390,000.

24 (V) for deferred maintenance of the U of A - Division of Agriculture,
25 in a sum not to exceed.....\$1,600,000.

26 (W) for deferred maintenance at the U of A - System, in a sum not to
27 exceed.....\$40,000.

28 (X) for deferred maintenance for the U of A - Fayetteville, in a sum
29 not to exceed.....\$9,090,000.

30 (Y) for the purchase, replacement, and renewal of equipment and library
31 holdings, in a sum not to exceed.....\$4,555,200.

33 SECTION 7. APPROPRIATION - UNIVERSITY OF ARKANSAS - LITTLE ROCK. There
34 is hereby appropriated, to the University of Arkansas at Little Rock, to be
35 payable from the General Improvement Fund or its successor fund or fund
36 accounts, the following:

1 (A) for improvements to technology infrastructure, in a sum not to
2 exceed.....\$4,000,000.

3 (B) for construction costs to complete the Nanotechnology Center, in a
4 sum not to exceed.....\$3,000,000.

5 (C) for the costs of improving and replacing building infrastructure
6 and performing critical maintenance, in a sum not to exceed....\$1,700,000.

7 (D) for critical maintenance, in a sum not to exceed.....\$6,620,000.

8 (E) for deferred maintenance, in a sum not to exceed.....\$5,300,000.

9 (F) for the purchase, replacement, and renewal of equipment and library
10 holdings, in a sum not to exceed.....\$1,802,560.

11

12 SECTION 8. APPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO. There
13 is hereby appropriated, to the University of Arkansas at Monticello, to be
14 payable from the General Improvement Fund or its successor fund or fund
15 accounts, the following:

16 (A) for costs of construction of the Workforce/Collegiate Center on the
17 Crossett campus, in a sum not to exceed.....\$1,050,000.

18 (B) for construction of a General Education Building on the McGehee
19 campus, in a sum not to exceed.....\$1,050,000.

20 (C) for construction of a Math and Science Center, in a sum not to
21 exceed.....\$3,500,000.

22 (D) for critical maintenance on the Crossett campus, in a sum not to
23 exceed.....\$40,000.

24 (E) for costs of renovation of the Old Student Union, in a sum not to
25 exceed.....\$2,000,000.

26 (F) for costs of renovation of the Library and Technology Center, in a
27 sum not to exceed.....\$325,000.

28 (G) for critical maintenance at the McGehee campus, in a sum not to
29 exceed.....\$70,000.

30 (H) for deferred maintenance at the McGehee campus, in a sum not to
31 exceed.....\$140,000.

32 (I) for deferred maintenance at the Crossett campus, in a sum not to
33 exceed.....\$110,000.

34 (J) the purchase, replacement, and renewal of equipment and library
35 holdings at the Crossett Campus, in a sum not to exceed.....\$27,895.

36 (K) for the purchase, replacement, and renewal of equipment and library

1 holdings at the McGehee Campus, in a sum not to exceed.....\$28,830.

2 (L) for costs of renovation of the Fine Arts Center, in a sum not to
3 exceed.....\$375,000.

4 (M) for critical maintenance, in a sum not to exceed.....\$1,340,000.

5 (N) for deferred maintenance, in a sum not to exceed.....\$1,710,000.

6 (O) for the purchase, replacement, and renewal of equipment and library
7 holdings, in a sum not to exceed.....\$387,969.

9 SECTION 9. APPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF. There
10 is hereby appropriated, to the University of Arkansas at Pine Bluff, to be
11 payable from the General Improvement Fund or its successor fund or fund
12 accounts, the following:

13 (A) for costs of campus renovations and repair, in a sum not to exceed
14\$3,000,000.

15 (B) for costs of construction of a Nanotechnology/Biotechnology Center,
16 in a sum not to exceed.....\$2,000,000.

17 (C) for costs of construction of a Life Sciences facility, in a sum not
18 to exceed.....\$1,200,000.

19 (D) for critical maintenance, in a sum not to exceed.....\$150,000.

20 (E) for deferred maintenance, in a sum not to exceed.....\$1,500,000.

21 (F) for the purchase, replacement, and renewal of equipment and library
22 holdings, in a sum not to exceed.....\$387,294.

23

24 SECTION 10. APPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH. There
25 is hereby appropriated, to the University of Arkansas - Fort Smith, to be
26 payable from the General Improvement Fund or its successor fund or fund
27 accounts, the following:

28 (A) for costs of designing, renovating, and equipping the Math-Science
29 building, in a sum not to exceed.....\$3,000,000.

30 (B) for costs of constructing an expanded Math-Science building, in a
31 sum not to exceed.....\$2,000,000.

32 (C) for costs of construction of a College of Business building, in a
33 sum not to exceed.....\$1,700,000.

34 (D) for critical maintenance, in a sum not to exceed.....\$290,000.

35 (E) for deferred maintenance, in a sum not to exceed.....\$1,460,000.

36 (F) for the purchase, replacement, and renewal of equipment and library

1 holdings, in a sum not to exceed.....\$829,488.

3 SECTION 11. APPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS. There is
4 hereby appropriated, to the University of Central Arkansas, to be payable
5 from the General Improvement Fund or its successor fund or fund accounts, the
6 following:

7 (A) for critical maintenance, in a sum not to exceed.....\$1,340,000.

8 (B) for costs of construction for an addition to, renovation of, and
9 equipment for the Lewis Science Center, in a sum not to exceed
10\$4,000,000.

11 (C) for costs of construction of the Institute for Wellness and
12 Restorative Health facility, in a sum not to exceed.....\$2,100,000.

13 (D) for costs of construction of a College of Fine Arts and
14 Communication building, in a sum not to exceed.....\$2,100,000.

15 (E) for deferred maintenance, in a sum not to exceed.....\$3,650,000.

16 (F) for the purchase, replacement, and renewal of equipment and library
17 holdings, in a sum not to exceed.....\$2,041,509.

19 SECTION 12. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
20 obligations otherwise incurred in relation to the project or projects
21 described herein in excess of the State Treasury funds actually available
22 therefor as provided by law. Provided, however, that institutions and
23 agencies listed herein shall have the authority to accept and use grants and
24 donations including Federal funds, and to use its unobligated cash income or
25 funds, or both available to it, for the purpose of supplementing the State
26 Treasury funds for financing the entire costs of the project or projects
27 enumerated herein. Provided further, that the appropriations and funds
28 otherwise provided by the General Assembly for Maintenance and General
29 Operations of the agency or institutions receiving appropriation herein shall
30 not be used for any of the purposes as appropriated in this act.

31 (B) The restrictions of any applicable provisions of the State Purchasing
32 Law, the General Accounting and Budgetary Procedures Law, the Revenue
33 Stabilization Law and any other applicable fiscal control laws of this State
34 and regulations promulgated by the Department of Finance and Administration,
35 as authorized by law, shall be strictly complied with in disbursement of any
36 funds provided by this act unless specifically provided otherwise by law.

SECTION 13. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 14. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2017 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2017 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2017.
