6	(3)(A) If a person other than an insurer owns a salvage vehicle			
7	for which a salvage vehicle title has not been issued, the owner shall			
8	surrender the certificate of title for the salvage vehicle to the office			
9	within thirty (30) days following the date that the motor vehicle became a			
10	salvage vehicle.			
11	(B) If a person other than an insurer owns a vehicle that

21	year of the occurrence."			
22	(b) $rac{Any}{a}$ title that is branded pursuant to under this subchapter			
23	shall retain the brand on the title for the life of the \underline{motor} vehicle.
