10 INSTITUTE TO EAST ARKANSAS COMMUNITY COLLEGE; TO
11 DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code Title 6, Chapter 51, is amended to add an
23 additional subchapter to read as follows:
24

Subchapter 11 –

Transfer of Crowley's Ridge Technical Institute to East Arkansas Community College

6-51-1101. Merger.

30 (a) On July 1, 2017, Crowley's Ridge Technical Institute is merged
31 with and into East Arkansas Community College.

32 (b) Except as provided in this subchapter, on July 1, 2017, all
33 statutory authority, powers, duties, functions, records, personnel, property,
34 unexpended balances of appropriations, allocations, or other funds, including
35 the functions of budgeting or purchasing, of Crowley's Ridge Technical
36 Institute are transferred to East Arkansas Community College.

2 6-51-1102. Board of directors and ex officio board of trustees.

3 On the effective date of this act, the Board of Directors of Crowley's
4 Ridge Technical Institute is abolished, and the Board of Directors of East
5 Arkansas Community College shall assume the powers and duties of the Board of
6 Directors of Crowley's Ridge Technical Institute.

7
8 6-51-1103. Purchasing.

9 (a) On and after July 1, 2017, purchases by East Arkansas Community
10 College may continue to be made under procedures that were applicable to East
11 Arkansas Community College or may be made under procedures that were
12 applicable to Crowley's Ridge Technical Institute.

13 (b) On and after July 1, 2017, flexibility in shop purchases, parts,
14 and house construction programs shall continue in the same manner authorized
15 for the original institutions.

16
17 6-51-1104. Transfer of assets, obligations, records, personnel,
18 property, unexpended balances, and legal authority.

19 (a) On July 1, 2017, all property and other rights, claims, and assets
20 of Crowley's Ridge Technical Institute are transferred to East Arkansas
21 Community College.

22 (b) On July 1, 2017, all obligations of Crowley's Ridge Technical
23 Institute are obligations of East Arkansas Community College.

24 (c)(1) Except as provided in subdivision (c)(2) of this section, on
25 July 1, 2017, all records, personnel, property, unexpended balances, and
26 legal authority are transferred from Crowley's Ridge Technical Institute to
27 East Arkansas Community College.

28 (2) The personnel transferred from Crowley's Ridge Technical
29 Institute to East Arkansas Community College shall comply with Section 3 of
30 this act.

31 (d) On and after July 1, 2017, all cash fund balances of Crowley's
32 Ridge Technical Institute transferred to East Arkansas Community College
33 shall be used for the operation, support, and improvement of occupational,
34 vocational, technical, and workforce development programs of East Arkansas
35 Community College.

1 6-51-1105. Funding from the Work Force 2000 Development Fund.
2 On and after July 1, 2017, funding from the Work Force 2000 Development
3 Fund, which would have been provided to Crowley's Ridge Technical Institute,
4 shall be provided to East Arkansas Community College to fund workforce
5 development, vocational, occupational, and training programs offered by East
6 Arkansas Community College.

7
8 6-51-1106. Funding from the Federal Adult Basic Education Fund.
9 On and after July 1, 2017, funding from the Federal Adult Basic
10 Education Fund, which would have been provided to Crowley's Ridge Technical
11 Institute, shall be provided to East Arkansas Community College.

12
13 SECTION 2. DO NOT CODIFY.

14 (a) The General Assembly finds that:

15 (1) Significant changes in the day-to-day operations of
16 Crowley's Ridge Technical Institute before July 1, 2017, may impede the
17 ability of the institution to merge seamlessly into East Arkansas Community
18 College; and

19 (2) Additional guidance and restrictions are necessary to assure
20 a smooth transition to the new institutional structure of East Arkansas
21 Community College created by this act.

22 (b) Except as provided in subsection (c) of this section, on and after
23 the effective date of this act and before July 1, 2017, Crowley's Ridge
24 Technical Institute shall not:

25 (1) Change its policies or procedures;

26 (2) Terminate an employee of Crowley's Ridge Technical
27 Institute;

28 (3) Transfer an employee of Crowley's Ridge Technical Institute
29 to a different position;

30 (4) Hire a new employee of Crowley's Ridge Technical Institute;
31 or

32 (5) Destroy, mutilate, or alter documents, records, or other
33 property maintained by Crowley's Ridge Technical Institute or its employees
34 unless the destruction, mutilation, or alteration is made in the normal
35 course of business and the nature of and reason for the destruction,
36 mutilation, or alteration are recorded.

(c) If Crowley's Ridge Technical Institute determines that performance of one (1) or more of the actions prohibited in subsection (b) of this section are necessary to appropriately perform the duties or functions of Crowley's Ridge Technical Institute:

(1) The Technical Institute Director or the Interim Technical Institute Director of Crowley's Ridge Technical Institute may request that the Board of Directors of East Arkansas Community College permit performance of the action; and

(2) The Board of Directors of East Arkansas Community College may grant or deny permission to perform the requested action.

(d) On and after the effective date of this act and before July 1, 2017, Crowley's Ridge Technical Institute shall provide to the President of East Arkansas Community College or his or her designee any document, record, testimony, explanation, or other information maintained by Crowley's Ridge Technical Institute or its employees upon the request of the President of East Arkansas Community College or his or her designee.

SECTION 3. Acts 2017, No. 94, § 1, is amended to read as follows:

SECTION 1. REGULAR SALARIES. There is hereby established for the Crowley's Ridge Technical Institute for the 2017-2018 fiscal year, the following maximum number of regular employees.

6 SECTION 4. DO NOT CODIFY. (a)(1) On or before January 31, 2018,
 7 active employees of Crowley's Ridge Technical Institute on June 30, 2017, who
 8 become employees of East Arkansas Community College under this act shall have
 9 the right to make a one-time choice between:

10 (A) The health insurance plan adopted by the State and
 11 Public School Life and Health Insurance Board for state employees; or

12 (B) The East Arkansas Community College health insurance
 13 plan.

14 (2) On or before January 31, 2018, active employees of Crowley's
 15 Ridge Technical Institute on June 30, 2017, who become employees of East
 16 Arkansas Community College under this act shall have the right to make a one-
 17 time choice between:

18 (A) Remaining in his or her same retirement system under
 19 the same conditions then provided by law or as may later be provided by law;
 20 or

21 (B) The East Arkansas Community College retirement system
 22 plan.

23 (b) The Board of Directors of East Arkansas Community College shall
 24 promulgate rules establishing the procedure for employees to exercise benefit
 25 options under subsection (a) of this section.

26

27 SECTION 5. DO NOT CODIFY. EFFECTIVE DATE. Section 3 of this act shall
 28 become effective on July 1, 2017.

29

30 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General
 31 Assembly of the State of Arkansas that Crowley's Ridge Technical Institute
 32 should be merged with East Arkansas Community College; that the merger will
 33 be best for the state, Crowley's Ridge Technical Institute, and East Arkansas
 34 Community College; that cooperation between Crowley's Ridge Technical
 35 Institute and East Arkansas Community College is necessary to effectuate the
 36 merger; and that this act is immediately necessary to allow a smooth

1 transition at the beginning of the fiscal year. Therefore, an emergency is
2 declared to exist, and this act being immediately necessary for the
3 preservation of the public peace, health, and safety shall become effective
4 on:

5 (1) The date of its approval by the Governor;

6 (2) If the bill is neither approved nor vetoed by the Governor,
7 the expiration of the period of time during which the Governor may veto the
8 bill; or

9 (3) If the bill is vetoed by the Governor and the veto is
10 overridden, the date the last house overrides the veto.
