20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code § 4-113-103 is repealed.

23 ~~4-113-103. Connect Arkansas Nonprofit organization Purposes~~

25 ~~(a) The Arkansas Capital Corporation may form a nonprofit corporation~~
26 ~~named "Connect Arkansas" to:~~

27 ~~(1) Prepare the people and businesses of Arkansas to secure the~~
28 ~~economic, educational, health, social, and other benefits available via~~
29 ~~broadband use;~~

30 ~~(2) Facilitate the availability of broadband service to every~~
31 ~~home and business in Arkansas;~~

32 ~~(3) Promote broadband based development in Arkansas, with the~~
33 ~~goals of facilitating:~~

34 ~~(A) Broadband education so that the citizens of every home~~
35 ~~and business in Arkansas can take full advantage of broadband services; and~~

36 ~~(B) The availability of broadband service to broadband-~~



1 ~~educated citizens in every home and business in Arkansas by the end of the~~
 2 ~~year 2012; and~~

3 ~~(4)(A) Recognize that services such as geographical information~~
 4 ~~system data delivery and high definition television programs require~~
 5 ~~increasingly huge demands in bandwidth; and~~

6 ~~(B) Promote broadband backbone networks that will serve~~
 7 ~~all of Arkansas with the bandwidth to support Arkansas home and business~~
 8 ~~needs into the foreseeable future.~~

9 ~~(b) The Governor, and with the consent of the Governor, the Arkansas~~
 10 ~~Economic Development Commission and any other state entity may make grants~~
 11 ~~available for the purpose of supporting Connect Arkansas.~~

15 ~~(a) Connect Arkansas will establish a method for broadband service~~
 16 ~~providers to register areas in which they provide broadband service to enable~~
 17 ~~Connect Arkansas to target locations where broadband is not currently offered~~
 18 ~~to Arkansas homes and businesses.~~

19 ~~(b) Specific registration requirements will be established by Connect~~
 20 ~~Arkansas, but competitive provider information shall be kept confidential by~~
 21 ~~Connect Arkansas.~~

22 ~~(c) Connect Arkansas shall execute nondisclosure agreements with~~
 23 ~~providers to guarantee confidentiality.~~

24 ~~(d) Connect Arkansas may disclose areas that are registered, the types~~
 25 ~~of broadband available in registered areas, and any provider information that~~
 26 ~~the provider identifies as acceptable for disclosure.~~

27 ~~(e) Registered areas are subject to verification by Connect Arkansas~~

1 ~~This subchapter shall be referred to and may be cited as the “Arkansas~~
 2 ~~Development Finance Corporation Act”.~~

 4 ~~15-4-902. Purposes.~~

5 ~~The purposes of each development finance corporation organized under~~
 6 ~~the provisions of this subchapter shall be to:~~

7 ~~(1) Promote, stimulate, develop, and advance the business~~
 8 ~~prosperity and economic welfare of the State of Arkansas and its citizens;~~

9 ~~(2) Encourage and assist, through loans, investments, or other~~
 10 ~~business transactions in the location of new business and industry in this~~
 11 ~~state and rehabilitate and assist existing business and industry;~~

12 ~~(3) Stimulate and assist in the expansion of all kinds of~~
 13 ~~business activity which will tend to promote the business development and~~
 14 ~~maintain the economic stability of this state;~~

15 ~~(4) Provide maximum opportunities for employment, encourage~~
 16 ~~thrift, and improve the standard of living of the citizens of this state;~~

17 ~~(5) Cooperate and act in conjunction with other public or~~
 18 ~~private organizations in the promotion and advancement of industrial,~~
 19 ~~commercial, agricultural, and recreational development in this state; and~~

20 ~~(6) Provide financing for the promotion, development, and~~

25 ~~(1) “Board” means the State Banking Board;~~

26 ~~(2) “Capital corporation” or “development finance corporation”~~
 27 ~~means a corporation authorized to be organized under the provisions of this~~
 28 ~~subchapter;~~

29 ~~(3) “Commissioner” means the Bank Commissioner; and~~

30 ~~(4) “Person”, as used in § 15-4-922, includes a natural person,~~
 31 ~~firm, association, corporation, joint stock company, trust, and trust estate.~~

 33 ~~15-4-904. Construction.~~

34 ~~(a) This subchapter shall be construed liberally.~~

35 ~~(b) The enumeration of any object, purpose, power, manner, method, or~~
 36 ~~thing shall not be deemed to exclude like or similar objects, purposes,~~

1 ~~powers, manners, methods, or things.~~

3 ~~15-4-905. Supervision.~~

4 ~~(a) Each development finance corporation organized under the~~
5 ~~provisions of this subchapter shall be subject to the supervision,~~
6 ~~examination, and control of the Bank Commissioner. It shall make such reports~~
7 ~~of its condition to the commissioner as the commissioner shall prescribe.~~

8 ~~(b) The commissioner is authorized to charge each development finance~~
9 ~~corporation under the commissioner's supervision assessment fees in order to~~
10 ~~defray the expenses of State Bank Department supervision and examination at~~
11 ~~the rate of forty five dollars (\$45.00) per examiner per hour of examination.~~

13 ~~15-4-906. Articles of incorporation.~~

14 ~~(a) The articles of incorporation for any development finance~~
15 ~~corporation organized under the provisions of this subchapter shall state:~~

16 ~~(1) The name of the development finance corporation. The name~~
17 ~~shall include the words "capital corporation" or "development finance~~
18 ~~corporation" and such other designation as necessary to distinguish it from~~
19 ~~any subsequent development finance corporation which may be organized under~~
20 ~~the provisions of this subchapter and to distinguish it from any other~~
21 ~~corporation organized and existing under the laws of the State of Arkansas;~~

22 ~~(2) The purpose for which the development finance corporation is~~
23 ~~formed;~~

24 ~~(3) The period of duration of the development finance~~
25 ~~corporation, which may be perpetual or limited;~~

26 ~~(4) The address of its principal office and the name and address~~
27 ~~of its agent upon whom process may be served;~~

28 ~~(5) The total number of shares of common stock which the~~
29 ~~development finance corporation is authorized to issue. The number shall be~~
30 ~~not less than one thousand (1,000) shares of common stock having a par value~~
31 ~~of one hundred dollars (\$100) per share;~~

32 ~~(6) The total number of shares of preferred stock which the~~
33 ~~development finance corporation is authorized to issue. The number shall be~~
34 ~~not less than thirty six thousand (36,000) shares of preferred stock having a~~
35 ~~par value of twenty five dollars (\$25.00) per share;~~

36 ~~(7) In addition to the ex officio directors, the number of~~

1 ~~directors, not fewer than six (6) nor more than fifteen (15), to be elected~~
2 ~~at the annual meeting of the holders of common stock, the terms of office of~~
3 ~~the directors, and any provisions desirable for staggering their terms of~~
4 ~~office, except that the terms of office of directors and other matters~~
5 ~~pertaining to the directors may be provided in the bylaws of the development~~

7 ~~(8) The names and addresses of the incorporators who, with the~~

14 ~~incorporation any of the corporate powers enumerated in this subchapter.~~

16 ~~15-4-907. Application for preliminary approval.~~

17 ~~Any fifteen (15) or more qualified natural persons, all of whom shall~~
18 ~~be bona fide residents of this state and among whom each of the congressional~~
19 ~~districts in the state shall have at least one (1) representative and who~~
20 ~~desire to associate themselves for the purpose of establishing and operating~~
21 ~~a development finance corporation, may subscribe, acknowledge, and file with~~
22 ~~the Bank Commissioner for preliminary approval proposed articles of~~
23 ~~incorporation, in duplicate, as authorized by § 15-4-906.~~

25 ~~15-4-908. Preliminary investigation.~~

26 ~~As soon as practicable after the receipt of the articles of~~
27 ~~incorporation, the Bank Commissioner shall, from the best source of~~
28 ~~information at his or her command:~~

29 ~~(1) Ascertain the qualifications, character, and general fitness~~
30 ~~of the applicants and their standing in their respective communities; and~~

31 ~~(2) Determine whether public convenience and necessity require a~~
32 ~~development finance corporation.~~

33
34 ~~15-4-909. Preliminary approval.~~

35 ~~If the Bank Commissioner is satisfied that the applicants are bona fide~~
36 ~~residents of the state, that each of the congressional districts in the state~~

1 is represented by at least one (1) applicant, that the applicants have the
 2 confidence of their respective communities, that public convenience and
 3 necessity require a development finance corporation, and that the proposed
 4 articles of incorporation conform to the provisions of § 15-4-906, the
 5 commissioner shall issue his or her certificate approving the articles of
 6 incorporation and authorizing the applicants to proceed with the organization
 7 of the development finance corporation.

10 Upon receipt of the certificate of preliminary approval, the applicants
 11 may proceed to complete the organization of the development finance
 12 corporation, to obtain subscriptions for and payment of its capital stock,
 13 and to do all other things necessarily incidental and preliminary to its
 14 transacting business.

 16 ~~15-4-911. Certificate of organization.~~

17 (a) ~~When the applicants shall have completed the organization of the~~
 18 ~~proposed development finance corporation, they shall file with the Bank~~
 19 ~~Commissioner a certificate of organization executed by the president of the~~
 20 ~~development finance corporation, attested by its secretary, and with its seal~~
 21 ~~affixed thereto, certifying:~~

22 ~~(1) The names and addresses of all of its subscribers of common~~
 23 ~~stock, the number of shares subscribed, and the number of shares fully paid~~
 24 ~~for by each;~~

25 ~~(2) The total number of shares of common stock subscribed but~~
 26 ~~not fully paid for;~~

27 ~~(3) The total number of shares of common stock paid in full;~~

28 ~~(4) The total number of shares of preferred stock subscribed but~~

1 ~~(b) The certificate of organization of the applicant shall be~~
2 ~~accompanied by the certificate of the named depository or by the certificates~~
3 ~~of the named depositories, if more than one (1), certifying the amount of the~~
4 ~~funds on deposit to the credit of the development finance corporation.~~

5 ~~(c) The certificate of organization shall be accompanied also by any~~
6 ~~bylaws or by any regulations which may have been adopted by the directors of~~
7 ~~the development finance corporation.~~

9 ~~15-4-912. Final investigation and approval by the board.~~

10 ~~(a) Immediately upon the filing of the certificate of organization by~~
11 ~~the applicants, the Bank Commissioner shall submit to the State Banking Board~~
12 ~~the proposed articles of incorporation and the certificate of organization of~~
13 ~~the applicants.~~

14 ~~(b) As soon as practicable thereafter, the board shall direct the~~
15 ~~commissioner to issue the applicants a certificate of incorporation in such~~
16 ~~form as it may prescribe, if the board, from the best source of information~~
17 ~~at its command, determines that:~~

18 ~~(1) Public convenience and necessity continue to require the~~
19 ~~development finance corporation;~~

20 ~~(2) The holders of the fully paid common stock of the~~
21 ~~development finance corporation are at least one hundred (100) in number;~~

22 ~~(3) All of the subscribers of the common stock of the~~
23 ~~development finance corporation are qualified natural persons and bona fide~~
24 ~~residents of the State of Arkansas;~~

25 ~~(4) Each congressional district in the state is represented by~~
26 ~~at least ten percent (10%) of the fully paid common stock of the development~~
27 ~~finance corporation and by at least one (1) member of the board of directors;~~

28 ~~(5) Not less than one hundred thousand dollars (\$100,000) of~~
29 ~~common stock has been subscribed and fully paid for;~~

30 ~~(6) Not less than nine hundred thousand dollars (\$900,000) of~~
31 ~~preferred stock has been subscribed and fully paid for; and~~

32 ~~(7) The bylaws and regulations submitted, if any, are in~~
33 ~~conformity with the articles of incorporation and the provisions of this~~
34 ~~subchapter, are not contrary to the laws of this state, and are otherwise~~
35 ~~satisfactory.~~

36 ~~(c) The commissioner shall return to the applicants one (1) of the~~

1 ~~copies of the articles of incorporation theretofore submitted to him or her~~
2 ~~by the applicants, upon which copy he or she shall have endorsed the fact of~~
3 ~~the issuance by him or her of the certificate of incorporation.~~

4 ~~(d) If bylaws and regulations are submitted and are found satisfactory~~
5 ~~by the board, the commissioner shall issue his or her certificate of approval~~

8 ~~15-4-913. Beginning of corporate existence — Certificate as evidence.~~

9 ~~(a) Upon the issuance of the certificate of incorporation by the Bank~~
10 ~~Commissioner, the corporate existence of the development finance corporation~~
11 ~~shall begin.~~

12 ~~(b) The certificate of incorporation shall be conclusive evidence,~~
13 ~~except as against the state, that all conditions precedent required to be~~
14 ~~performed by the applicants have been complied with and that the development~~
15 ~~finance corporation has been incorporated under this subchapter.~~

16 ~~(c) A copy of the articles of incorporation so endorsed by the~~
17 ~~commissioner, as prescribed in § 15-4-912, shall be filed for recordation in~~

21 ~~15-4-914. Amendment to articles of incorporation.~~

22 ~~(a) A development finance corporation organized under the provisions~~
23 ~~of this subchapter may amend its articles of incorporation by a majority vote~~
24 ~~of the stock, represented in person or by proxy at any regular meeting or at~~
25 ~~any special meeting of the holders of the common stock called for that~~
26 ~~purpose.~~

27 ~~(b) The power to amend shall include the power to accomplish any~~
28 ~~desired change in the provisions of the articles of incorporation and to~~
29 ~~include any purpose, power, or provision authorized to be included in the~~
30 ~~original articles of incorporation or by any amendment to this subchapter.~~

31 ~~(c) Articles of amendment signed by the president or vice president~~
32 ~~and attested by the secretary certifying to such amendment and its lawful~~
33 ~~adoption shall be executed, acknowledged, and filed with the Bank~~
34 ~~Commissioner and when approved by the State Banking Board recorded with a~~
35 ~~certificate of the commissioner approving the articles of amendment in the~~

4 ~~15-4-915. Management of corporation—Voting and transfer of common~~
5 ~~stock.~~

6 ~~(a) Only the holders of common stock, through the board of directors,~~
7 ~~shall manage the affairs of the development finance corporation. Each holder~~
8 ~~of common stock shall be entitled to one (1) vote, in person or by proxy, for~~
9 ~~each share of common stock held by him or her and, in voting for the~~
10 ~~directors of the development finance corporation, shall be entitled to~~
11 ~~exercise the right of cumulative voting, except that ex officio directors~~
12 ~~shall be excluded from any calculation with respect to cumulative voting.~~

13 ~~(b) In the event of the transfer of shares of common stock, whether by~~
14 ~~act of the holder or by operation of law, the names of the proposed~~
15 ~~transferees shall be submitted to the directors of the development finance~~
16 ~~corporation and the directors may refuse to approve the transfer. In this~~
17 ~~event, the development finance corporation shall have the option to purchase~~
18 ~~the shares of common stock at par. Shares of common stock so purchased shall~~
19 ~~be cancelled and shares in lieu thereof may be reissued and sold by the~~
20 ~~development finance corporation. In the event that the directors do not~~
21 ~~purchase the shares of common stock subject to transfer, the shares of common~~
22 ~~stock then may be transferred without the approval of the directors.~~

23 ~~(c)(1)(A) In addition to the directors elected by the holders of~~
24 ~~common stock of a development finance corporation, the Executive Director of~~
25 ~~the Arkansas Economic Development Commission and the President of the~~
26 ~~Arkansas Development Finance Authority, or persons holding similar executive~~
27 ~~positions in any agency or instrumentality succeeding thereto, shall be ex~~
28 ~~officio members of the board of directors of each development finance~~
29 ~~corporation created under this subchapter.~~

30 ~~(B) Ex officio directors shall have all rights, duties,~~
31 ~~and obligations of a director except that their terms of office shall be~~
32 ~~concurrent with their employment in the position by the respective agencies~~
33 ~~and shall be deemed to have resigned as a director of the development finance~~
34 ~~corporation when such employment is terminated.~~

35 ~~(C) The successor to such a person shall become a director~~
36 ~~without further action by the board of directors upon receipt of written~~

1 notice by the president of the development finance corporation from the chair
 2 of the board or commission of the respective agency that the person has
 3 become so employed.

4 (2) ~~It shall not be necessary to amend the articles of~~
 5 ~~incorporation of any development finance corporation organized and existing~~

 10 ~~15-4-916. Powers.~~

11 ~~In furtherance of the purposes set out in § 15-4-902, each development~~
 12 ~~finance corporation organized under this subchapter shall have the power:~~

13 (1) ~~To sue and be sued, complain, and defend in its corporate~~
 14 ~~name;~~

15 (2) ~~To have perpetual succession unless a limited period of~~
 16 ~~duration is stated in its articles of incorporation;~~

17 (3) ~~To adopt a corporate seal, which may be altered at pleasure,~~
 18 ~~and to use it or a facsimile thereof as required by law;~~

19 (4) ~~Within the limitations hereinafter imposed and in the manner~~
 20 ~~hereinafter prescribed, to borrow money and otherwise contract indebtedness,~~
 21 ~~to issue its bonds, notes, debentures, or other obligations therefor with or~~
 22 ~~without security, and, if with security, to secure the payment thereof by~~
 23 ~~mortgage, pledge, or deed of trust on all or any part of its property,~~
 24 ~~assets, revenues, or income;~~

25 (5) ~~To purchase, receive, lease as lessee, or in any other~~
 26 ~~manner acquire, own, hold, maintain, sell, exchange, and use any and all real~~

21 ~~(14) With the approval of the State Banking Board, by action of~~
22 ~~the directors of the development finance corporation, to make and alter~~
23 ~~bylaws and regulations not inconsistent with the articles of incorporation or~~
24 ~~with the laws of this state for the administration and regulation of the~~
25 ~~affairs of the development finance corporation;~~

26 ~~(15) To encourage and promote the cultural, industrial,~~
27 ~~economic, and recreational development of the State of Arkansas;~~

1 ~~(C) In order to comply with this requirement, efforts must~~
2 ~~be made to solicit for review and analysis proposed minority business~~
3 ~~ventures.~~

4 ~~(D) Basic loan underwriting standards will not be waived~~
5 ~~to inconsistently favor minority persons or businesses, or both, from the~~
6 ~~intent of the development finance corporation's lending practices.~~

8 ~~15-4-917. Corporation to be nonprofit—Use of revenues.~~

9 ~~(a) Each development finance corporation organized under the~~
10 ~~provisions of this subchapter shall be operated without profit to its~~
11 ~~members. No dividends shall be declared at any time on the common or~~
12 ~~preferred stock of such a development finance corporation.~~

13 ~~(b) All revenues of the development finance corporation shall be~~
14 ~~devoted to the payment of interest on the bonds of the development finance~~
15 ~~corporation, to the maintenance of reserves, to the establishment and~~
16 ~~maintenance of a sinking fund for the retirement of debentures, and to~~
17 ~~transfers to earned surplus, substantially in the order named, but as may be~~
18 ~~more fully provided in the bylaws of the corporation.~~

19
20 ~~15-4-918. Liability of directors and officers.~~

21 ~~The directors and officers of the development finance corporation~~
22 ~~organized under the provisions of this subchapter shall not be responsible~~
23 ~~for losses unless the losses shall have been occasioned by the willful~~
24 ~~misconduct of such directors or officers.~~

25
26 ~~15-4-919. Retirement of preferred stock.~~

27 ~~(a) The outstanding preferred stock of a development finance~~
