18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. Arkansas Code § 19-6-301(148), concerning the enumeration
21 of special revenues, is amended to read as follows:

22 (148) That portion of commercial driver license application
23 fees, § 27-23-118(a)(1); driver search fees, §§ 27-23-118(b)(1), ~~and~~ § 27-23-
24 118(c)(1), and § 27-23-118(c)(3); and all fines, forfeitures, and penalties
25 collected under § 27-23-118(d) of the Arkansas Uniform Commercial Driver
26 License Act, § 27-23-101 et seq.;

28 SECTION 2. Arkansas Code § 19-6-404(1), concerning the Department of
29 Arkansas State Police Fund, is amended to read as follows:

30 (1) Those special revenues as specified in § 19-6-301(1), (5),
31 (7), (8), (38)-(40), (94), 148, (150), (168), (175), (184)-(186), (190),
32 (218)-(220), (222), (226), (227), (234), and (252);

34 SECTION 3. Arkansas Code § 27-23-117(3), concerning driver information
35 to be furnished, is amended to read as follows:

1 (3) To others, authorized to receive the information pursuant to
2 § 27-50-906, upon request and payment of a fee of ~~seven dollars (\$7.00)~~ ten
3 dollars (\$10.00).

5 SECTION 4. Arkansas Code § 27-23-118(c), concerning the distribution
6 of fees, is amended to read as follows:

7 (c) The fee set out in § 27-23-117(3) shall be deposited as special
8 revenues into the State Treasury and distributed as follows:

9 (1) One dollar (\$1.00) of the fee shall be deposited to the
10 credit of the Revenue Division of the Department of Finance and
11 Administration in the Commercial Driver License Fund; ~~and~~

12 (2) ~~The remaining six~~ Six dollars (\$6.00) of the fee shall be
13 deposited to the credit of the State Highway and Transportation Department
14 Fund for distribution as provided in the Arkansas Highway Revenue
15 Distribution Law, § 27-70-201 et seq.; and

16 (3) The remaining three dollars (\$3.00) shall be deposited to
17 the credit of the Department of Arkansas State Police Fund to be used for the
18 purchase of motor vehicles, any associated taxes, equipping costs, and other
19 department operations.

21 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the
22 General Assembly of the State of Arkansas that such revision be given effect
23 on July 1, 2017, in order that the effective date of the act will coincide
24 with the beginning of a new fiscal year; that under the Arkansas
25 Constitution, acts without an emergency clause do not take effect until
26 ninety (90) days after adjournment of the General Assembly and that unless an
27 emergency is declared, extension of the regular session of the General
28 Assembly will result in a delay in the effectiveness of this act beyond July
29 1 and would work irreparable harm upon the citizens of this state.
30 Therefore, an emergency is hereby declared to exist and this act being
31 necessary for the immediate preservation of the public peace, health and
32 safety shall be in full force and effect from and after its passage and
33 approval.
