11	(a)(1) The committee so empowered A committee of either house of the		
12	General Assembly or a joint committee of both houses of the General Assembly		
13	may issue $ ext{its}$ $ ext{a}$ subpoena $ ext{signed}$ by its chair or acting chair for the		
14	attendance of witnesses and the production of papers or records, and the		
15	subpoena may be served by any officer authorized to serve process in civil		
16	eases.		
17	(2) The subpoena may be served by any officer authorized to		
18	serve process in civil cases.		
19	(b)(1) A subpoena issued by a committee of either house of the Genera		
20	Assembly or a joint committee of both houses of the General Assembly shall be		
21	signed by:		
22	(A) The chair or acting chair of the committee, if issued		
23	by a committee of either house of the General Assembly; or		
24	(B) The cochairs or acting cochairs of the committee, if		
25	issued by a joint committee of both houses of the General Assembly.		
26	(2) Additional signatures shall not be required for the issuance		
27	of a subpoena by a committee of either house of the General Assembly or a		
28	joint committee of both houses of the General Assembly.
