20 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 21 22 EXTRA HELP. There is hereby authorized, for the Department of Finance and 23 Administration - Division of Racing for the 2017-2018 2018-2019 fiscal year, 24 the maximum number of thirty-one (31) part-time or temporary employees, to be 25 known as "Extra Help", payable from funds appropriated herein for such 26 purposes, such employees shall be authorized to work over 1,000 hours per 27 year.

28 The provisions of this section shall be in effect only from July 1, 2017
29 <u>2018</u> through June 30, <del>2018</del> <u>2019</u>.

31 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 32 authorized by this act shall be limited to the appropriation for such agency 33 and funds made available by law for the support of such appropriations; and 34 the restrictions of the State Procurement Law, the General Accounting and 35 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 36 Procedures and Restrictions Act, or their successors, and other fiscal

1 control laws of this State, where applicable, and regulations promulgated by 2 the Department of Finance and Administration, as authorized by law, shall be 3 strictly complied with in disbursement of said funds. 

SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.
