SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS VETERANS' INITIATIVE. The appropriation authorized in this Act for Arkansas Veterans' Initiative, Stories of Service is not intended to be carried forward into the base level for the purposes of budget preparation. Any appropriation request for this purpose shall be considered a new appropriation request, and therefore will be considered a change level budget request.

Notwithstanding any law pertaining to the transfer of year-end fund balances or any law to the contrary, any funds provided to the Educational Television Fund Account for the purpose of funding the Arkansas Veterans' Initiative Appropriation which remain in the Educational Television Fund Account at the end of a fiscal year shall remain in the Educational Television Fund Account and shall continue to be allocated to the Arkansas Veterans' Initiative Appropriation in the following fiscal year.

1	The provisions of this section shall be in effect only from July 1, $\frac{2017}{}$
2	<u>2018</u> through June 30, <u>2018</u> <u>2019</u> .
3	
4	SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
5	authorized by this act shall be limited to the appropriation for such agency
6	and funds made available by law for the support of such appropriations; and
7	the restrictions of the State Procurement Law, the General Accounting and
8	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
9	Procedures and Restrictions Act, or their successors, and other fiscal
10	control laws of this State, where applicable, and regulations promulgated by
11	the Department of Finance and Administration, as authorized by law, shall be
12	strictly complied with in disbursement of said funds.
13	
14	SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
15	Assembly that any funds disbursed under the authority of the appropriations
16	contained in this act shall be in compliance with the stated reasons for
17	which this act was adopted, as evidenced by the Agency Requests, Executive
18	Recommendations and Legislative Recommendations contained in the budget
19	manuals prepared by the Department of Finance and Administration, letters, or
20	summarized oral testimony in the official minutes of the Arkansas Legislative
21	Council or Joint Budget Committee which relate to its passage and adoption.
22	
23	SECTION 10. EFFECTIVE DATE. This act is effective on and after July 1,
24	<u>2018.</u>
