20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

5 PROMOTIONAL ITEMS. The Department of Arkansas State Police is hereby
6 authorized to purchase from Maintenance & General Operations Classifications
7 in the Operations Appropriation provided by this Act, up to an amount not to
8 exceed \$2,500 each fiscal year, promotional items, authorized by the Director
9 of the Department to meet requirements of the Arkansas State Police Strategic
10 Recruitment Plan.

11 The provisions of this section shall be in effect only from July 1, ~~2017~~

14 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OVERTIME.

16 The Department of Arkansas State Police is hereby authorized to make overtime
17 payments from such funds and appropriations provided for overtime payments to
18 those officers or other employees that are currently assigned or may be
19 assigned by the Director of the Department of Arkansas State Police to
20 Special Law Enforcement Task Forces and other special programs reimbursable
21 to Arkansas State Police by federal or local authorities as approved by the
22 Director of the Department of Arkansas State Police. All such overtime
23 payments shall be processed through the State Accounting System and shall be
24 in addition to the Regular Salaries and benefits accruing to the employee.
25 Payment of overtime is the preferred method of implementing the provisions of
26 this section.

27 The provisions of this section shall be in effect only from July 1, ~~2017~~
28 2018 through June 30, ~~2018~~ 2019.

30 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR

32 VEHICLE PURCHASE. The Department of Arkansas State Police is hereby
33 authorized to purchase motor vehicles from the appropriations authorized for
34 Capital Outlay in the State Police Operations and/or Confiscated Funds
35 Transfer appropriation in this Act. Motor vehicles donated to Arkansas State
36 Police and confiscated vehicles used for Arkansas State Police operations

1 shall not be included in the maximum number of authorized passenger vehicles.

2 The provisions of this section shall be in effect only from July 1, 2017
3 2018 through June 30, ~~2018~~ 2019.

5 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. UNIFORM
7 EMPLOYEE HEALTH INSURANCE PROGRAM REPORTING. The Department of Arkansas
8 State Police shall report monthly to the Governor, the Chief Fiscal Officer
9 of the State and to the Arkansas Legislative Council or Joint Budget
10 Committee regarding the activity and condition for the uniformed employee
11 health insurance plan. The report shall include, but not limited to, the
12 beginning reserve fund balance, contributions made during the month, claims
13 paid, and the ending fund balance of the month. In the event it is determined
14 that the cost to adequately maintain the uniform employee health insurance
15 plan is not feasible within the existing resources available to the
16 department, the 91st General Assembly shall study the feasibility and
17 desirability of discontinuing the self-insurance program and instead provide
18 medical and hospital insurance to uniform employees through the public
19 employees insurance program.

20 The provisions of this section shall be in effect only from July 1, 2017
21 2018 through June 30, ~~2018~~ 2019.

22
23 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
25 EXTRAORDINARY EXPENSES. The Department of Arkansas State Police is hereby
26 authorized to purchase from Maintenance & Operations Classifications in the
27 Operations Appropriation provided by this Act, up to an amount not to exceed
28 two thousand five hundred dollars (\$2,500) each fiscal year, for emergency
29 purchases for food, drinks and other essential items during emergency
30 operations only when authorized by the Agency Director. During an emergency,
31 an ASP employee may be designated and authorized, by the Director, to incur
32 expenses for all deployed personnel.

33 The provisions of this section shall be in effect only from July 1, 2017
34 2018 through June 30, ~~2018~~ 2019.

35
36 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
2 WIRELESS INFORMATION NETWORK. Once the requirements of Arkansas Code §12-8-
3 310 are satisfied, the second two million five hundred thousand dollars
4 (\$2,500,000) deposited into the Department of Arkansas State Police Fund
5 generated by Arkansas Code §27-16-801(a) shall be used for the operations,
6 maintenance, equipment and various system requirements and expenses of the
7 Department of Arkansas State Police - Arkansas Wireless Information Network.

8 The provisions of this section shall be in effect only from July 1, ~~2017~~
9 2018 through June 30, ~~2018~~ 2019.

10
11 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. QUARTERLY
13 REPORTING. The Department of Arkansas State Police shall on a quarterly basis
14 provide to the Arkansas Legislative Council or Joint Budget Committee a
15 report detailing expenditures from the Court Awards Fund of the Confiscated
16 Funds Transfer appropriation of this Act. The report shall include the State
17 Police division, purpose and amount of expenditures.

18 The quarterly reports shall be provided no later than the 15th day of the
19 month immediately following the end of each quarter.

20 The provisions of this section shall be in effect only from July 1, ~~2017~~
21 2018 through June 30, ~~2018~~ 2019.

22
23 SECTION 21. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
24 authorized by this act shall be limited to the appropriation for such agency
25 and funds made available by law for the support of such appropriations; and
26 the restrictions of the State Procurement Law, the General Accounting and
27 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
28 Procedures and Restrictions Act, or their successors, and other fiscal
29 control laws of this State, where applicable, and regulations promulgated by
30 the Department of Finance and Administration, as authorized by law, shall be
31 strictly complied with in disbursement of said funds.

32
33 SECTION 22. LEGISLATIVE INTENT. It is the intent of the General
34 Assembly that any funds disbursed under the authority of the appropriations
35 contained in this act shall be in compliance with the stated reasons for
36 which this act was adopted, as evidenced by the Agency Requests, Executive

1 Recommendations and Legislative Recommendations contained in the budget
2 manuals prepared by the Department of Finance and Administration, letters, or
3 summarized oral testimony in the official minutes of the Arkansas Legislative
4 Council or Joint Budget Committee which relate to its passage and adoption.
5

6 SECTION 23. EFFECTIVE DATE. This act is effective on and after July 1,
7 2018.
