2 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for 3 the Department of Human Services - Division of Provider Services and Quality 4 Assurance for the 2018-2019 fiscal year, the following maximum number of 5 part-time or temporary employees, to be known as "Extra Help", payable from 6 funds appropriated herein for such purposes: eight (8) temporary or part-7 time employees, when needed, at rates of pay not to exceed those provided in 8 the Uniform Classification and Compensation Act, or its successor, or this 9 act for the appropriate classification.

11 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, 12 to the Department of Human Services - Division of Provider Services and 13 Quality Assurance, to be payable from the paying account as determined by the 14 Chief Fiscal Officer of the State, for personal services and operating 15 expenses of the Department of Human Services - Division of Provider Services 16 and Quality Assurance for the fiscal year ending June 30, 2019, the 17 following:

33 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 34 authorized by this act shall be limited to the appropriation for such agency 35 and funds made available by law for the support of such appropriations; and 36 the restrictions of the State Procurement Law, the General Accounting and

Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
Procedures and Restrictions Act, or their successors, and other fiscal
control laws of this State, where applicable, and regulations promulgated by
the Department of Finance and Administration, as authorized by law, shall be
strictly complied with in disbursement of said funds.

7 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General 8 Assembly that any funds disbursed under the authority of the appropriations 9 contained in this act shall be in compliance with the stated reasons for 10 which this act was adopted, as evidenced by the Agency Requests, Executive 11 Recommendations and Legislative Recommendations contained in the budget 12 manuals prepared by the Department of Finance and Administration, letters, or 13 summarized oral testimony in the official minutes of the Arkansas Legislative 14 Council or Joint Budget Committee which relate to its passage and adoption.
