9 AND OPERATING EXPENSES FOR THE DEPARTMENT OF HUMAN  
10 SERVICES - DIVISION OF PROVIDER SERVICES AND QUALITY  
11 ASSURANCE FOR THE FISCAL YEAR ENDING JUNE 30, 2019;  
12 AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT FOR THE DEPARTMENT OF HUMAN  
16 SERVICES - DIVISION OF PROVIDER SERVICES  
17 AND QUALITY ASSURANCE APPROPRIATION FOR  
18 THE 2018-2019 FISCAL YEAR.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
25 for the Department of Human Services - Division of Provider Services and  
26 Quality Assurance for the 2018-2019 fiscal year, the following maximum number  
27 of regular employees.

 2 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for  
 3 the Department of Human Services - Division of Provider Services and Quality  
 4 Assurance for the 2018-2019 fiscal year, the following maximum number of  
 5 part-time or temporary employees, to be known as "Extra Help", payable from  
 6 funds appropriated herein for such purposes: eight (8) temporary or part-  
 7 time employees, when needed, at rates of pay not to exceed those provided in  
 8 the Uniform Classification and Compensation Act, or its successor, or this  
 9 act for the appropriate classification.

10  
 11 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 12 to the Department of Human Services - Division of Provider Services and  
 13 Quality Assurance, to be payable from the paying account as determined by the  
 14 Chief Fiscal Officer of the State, for personal services and operating  
 15 expenses of the Department of Human Services - Division of Provider Services  
 16 and Quality Assurance for the fiscal year ending June 30, 2019, the  
 17 following:

 33 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. The  
 35 Division of Provider Services and Quality Assurance of the Department of  
 36 Human Services is authorized to use funds appropriated for the certification

1 or licensure of an entity on behalf of any division of the Department of  
2 Human Services. Any entity holding a certification or license funded through  
3 an appropriation for the Division of Provider Services and Quality Assurance  
4 of the Department of Human Services shall hold its certification or license  
5 under the authority of the relevant division of the Department of Human  
6 Services. All laws that apply to a certified or licensed entity by a relevant  
7 division of the Department of Human Services shall apply to an entity  
8 certified or licensed by the Division of Provider Services and Quality  
9 Assurance on behalf of a relevant division of the Department of Human  
10 Services.

11 The provisions of this section shall be in effect only from July 1,  
12 2018 through June 30, 2019.

13  
14 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
15 authorized by this act shall be limited to the appropriation for such agency  
16 and funds made available by law for the support of such appropriations; and  
17 the restrictions of the State Procurement Law, the General Accounting and  
18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
19 Procedures and Restrictions Act, or their successors, and other fiscal  
20 control laws of this State, where applicable, and regulations promulgated by  
21 the Department of Finance and Administration, as authorized by law, shall be  
22 strictly complied with in disbursement of said funds.

23  
24 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General  
25 Assembly that any funds disbursed under the authority of the appropriations  
26 contained in this act shall be in compliance with the stated reasons for  
27 which this act was adopted, as evidenced by the Agency Requests, Executive  
28 Recommendations and Legislative Recommendations contained in the budget  
29 manuals prepared by the Department of Finance and Administration, letters, or  
30 summarized oral testimony in the official minutes of the Arkansas Legislative  
31 Council or Joint Budget Committee which relate to its passage and adoption.

32  
33 SECTION 7. EFFECTIVE DATE. This act is effective on and after July 1,  
34 2018.
