SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 6 7 DISTRIBUTION OF FUNDS. Funding provided in Property Tax Relief Fund Revenues Distribution to Counties and Property Tax Relief Fund Revenues Distribution to 8 9 Cities of this Act from the Property Tax Relief Trust Fund shall not be 10 distributed unless there are sufficient funds in the Property Tax Relief Trust 11 Fund as of the date that the Chief Fiscal Officer of the State certifies the 12 amount in excess of the required reimbursement to the counties as provided in 13 §26-26-310(b)(2)(C)(i). If there are sufficient funds remaining in the 14 Property Tax Relief Trust Fund on December 31, 2017 2018, as certified, the 15 Treasurer shall distribute two million dollars (\$2,000,000) to counties and 16 two million dollars (\$2,000,000) to cities for the fiscal year ending June 30, 17 2018 2019 from the balance remaining on December 31, 2017 2018 from the 18 Property Tax Relief Trust Fund. The distribution to counties shall be made in 19 accordance with the distribution formula in §19-5-602(c). The distribution to 20 cities shall be made in accordance with the distribution formula in §19-5-21 601(b). The funds attributable to sales and use taxes levied prior to July 1, 22 2017 2018 shall not be transferred from the Property Tax Relief Trust Fund to 23 the cities and counties.

The provisions of this section shall be in effect only from July 1, 2017

27 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COUNTY 29 TURNBACK - UNANTICIPATED FUNDS. The appropriation authorized for General 30 Revenue to Counties or any other appropriation as provided by the General 31 Assembly for aid to counties may be supplemented, if necessary, by a transfer 32 from the appropriation provided for Unanticipated Special Revenues in this 33 Act.

The provisions of this section shall be in effect only from July 1, 2017
<u>2018</u> through June 30, 2018 2019.

1 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LOANS TO 3 CITIES AND COUNTIES. On July 1 of each fiscal year, the Chief Fiscal Officer 4 of the State shall request a transfer by the State Treasurer from the Budget 5 Stabilization Trust Fund to the County Aid Fund and to the Municipal Aid Fund 6 to assist the various cities and counties in meeting cash flow needs early in 7 the state fiscal year. The transfer shall be a loan to be repaid in equal 8 installments from general revenue distributions each month during the fiscal 9 year for which the loan was made and shall be in addition to any other loans 10 authorized by law for the County Aid and Municipal Aid Funds. The amount of 11 such loan for each fiscal year shall be \$3,517,657 to the Municipal Aid Fund 12 and \$1,906,079 to the County Aid Fund, or so much thereof as may be available in the Budget Stabilization Trust Fund as determined by the Chief Fiscal 13 14 Officer of the State. Upon such transfer being completed, the State 15 Treasurer shall immediately distribute such funds to each of the several 16 municipalities and counties in the same manner as general revenues are 17 distributed.

18 It is the intent of the General Assembly that the Chief Fiscal Officer of the 19 State and the State Treasurer shall make every reasonable, and financially 20 sound effort to insure that local governments receive the full amount of the 21 loan authorized herein on July 1 of each year and that the monies authorized 22 for local governments from general revenues be distributed in equal monthly 23 payments.

24 The provisions of this section shall be in effect only from July 1, 2017 25 <u>2018</u> through June 30, 2018 <u>2019</u>.

26

27 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY 29 FORWARD. At the close of each fiscal year any unexpended funds for the 30 County Aid and Municipal Aid line items shall be carried forward and 31 distributed pursuant and in addition to the funding formula established under 32 A.C.A 19-5-601 and 19-5-602 within forty-five (45) days.

Any carry forward of unexpended balance of funding as authorized herein,may be carried forward under the following conditions:

35 (1) Prior to June 30, 2018 2019 the Agency shall by written statement
36 set forth its reason(s) for the need to carry forward said funding to the

1 Department of Finance and Administration Office of Budget;

2 (2) The Department of Finance and Administration Office of Budget shall 3 report to the Arkansas Legislative Council all amounts carried forward by the 4 September Arkansas Legislative Council or Joint Budget Committee meeting 5 which report shall include the name of the Agency, Board, Commission or 6 Institution and the amount of the funding carried forward, the program name 7 or line item, the funding source of that appropriation and a copy of the 8 written request set forth in (1) above;

9 (3) Each Agency, Board, Commission or Institution shall provide a 10 written report to the Arkansas Legislative Council or Joint Budget Committee 11 containing all information set forth in item (2) above, along with a written 12 statement as to the current status of the project, contract, purpose etc. for 13 which the carry forward was originally requested no later than thirty (30) 14 days prior to the time the Agency, Board, Commission or Institution presents 15 its budget request to the Arkansas Legislative Council/Joint Budget 16 Committee; and

17 (4) Thereupon, the Department of Finance and Administration shall 18 include all information obtained in item (3) above in the budget manuals 19 and/or a statement of non-compliance by the Agency, Board, Commission or 20 Institution.

21 The provisions of this section shall be in effect only from July 1, 2017
22 <u>2018</u> through June 30, 2018 <u>2019</u>.

24 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TURNBACK 26 REPORTING. Each calendar year each county and municipality receiving total 27 highway revenues and highway severance turnback per A.C.A 27-70-207 and A.C.A 28 26-58-124 of \$2,000,000 or more shall report to the House Public 29 Transportation Committee and the Senate Transportation, Technology and 30 Legislative Affairs Committee indicating how highway revenues and highway 31 severance turnback funds were utilized. The report shall include a general 32 ledger accounting of the city or county street/road fund. The county report 33 shall be made utilizing the County Financial Management System of tracking 34 county revenues and expenditures. The report shall also include the 35 percentage of the street/road fund that is comprised of state funds. Further, 36 the report shall include details of each contracted project including type

and description of project and total amount of money spent on the project.
 The report shall be submitted annually no later than March 15th for the
 previous year's projects.

4 The provisions of this section shall be in effect only from July 1, 2017
5 <u>2018</u> through June 30, 2018 <u>2019</u>.

7 SECTION 14. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 8 authorized by this act shall be limited to the appropriation for such agency 9 and funds made available by law for the support of such appropriations; and 10 the restrictions of the State Procurement Law, the General Accounting and 11 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 12 Procedures and Restrictions Act, or their successors, and other fiscal 13 control laws of this State, where applicable, and regulations promulgated by 14 the Department of Finance and Administration, as authorized by law, shall be 15 strictly complied with in disbursement of said funds.

17 SECTION 15. LEGISLATIVE INTENT. It is the intent of the General 18 Assembly that any funds disbursed under the authority of the appropriations 19 contained in this act shall be in compliance with the stated reasons for 20 which this act was adopted, as evidenced by the Agency Requests, Executive 21 Recommendations and Legislative Recommendations contained in the budget 22 manuals prepared by the Department of Finance and Administration, letters, or 23 summarized oral testimony in the official minutes of the Arkansas Legislative 24 Council or Joint Budget Committee which relate to its passage and adoption. 25
