2 SECTION 2. REAPPROPRIATION - CAPITAL PROJECTS. There is hereby 3 appropriated, to the Department of Finance and Administration - Building 4 Authority Division, to be payable from the General Improvement Fund or its 5 successor fund or fund accounts, for the Department of Finance and 6 Administration - Building Authority Division the following:

7 (A) Effective July 1, 2018, the balance of the appropriation provided 8 in Item (A) of Section 1 of Act 218 of 2017, for various maintenance, 9 renovation, equipping, construction, acquisition, improvement, upgrade, and 10 repair projects for all state-owned real property and facilities, in a sum 11 not to exceed\$160,000,000.

SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor 13 14 obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available 15 16 therefor as provided by law. Provided, however, that institutions and 17 agencies listed herein shall have the authority to accept and use grants and 18 donations including Federal funds, and to use its unobligated cash income or 19 funds, or both available to it, for the purpose of supplementing the State 20 Treasury funds for financing the entire costs of the project or projects 21 enumerated herein. Provided further, that the appropriations and funds 22 otherwise provided by the General Assembly for Maintenance and General 23 Operations of the agency or institutions receiving appropriation herein shall 24 not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.
