20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
23 for the Office of the Governor for the 2018-2019 fiscal year, the following
24 maximum number of regular employees.

7 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for
 8 the Office of the Governor for the 2018-2019 fiscal year, the following
 9 maximum number of part-time or temporary employees, to be known as "Extra
 10 Help", payable from funds appropriated herein for such purposes: seven (7)
 11 temporary or part-time employees, when needed, at rates of pay not to exceed
 12 those provided in the Uniform Classification and Compensation Act, or its
 13 successor, or this act for the appropriate classification.

15 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 16 to the Office of the Governor, to be payable from the State Central Services
 17 Fund, for personal services and operating expenses of the Office of the
 18 Governor for the fiscal year ending June 30, 2019, the following:

33 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 35 PROVISION. After receiving approval from the Chief Fiscal Officer of the
 36 State, and prior review by the Arkansas Legislative Council or Joint Budget

1 Committee, the Agency is authorized to transfer appropriation from any line
2 item authorized in Operations Appropriation of the Governor's Office in this
3 Act to any other line item authorized in Operations Appropriation.

4 The provisions of this section shall be in effect only from July 1, ~~2017~~
5 2018 through June 30, ~~2018~~ 2019.

7 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARIES.
9 In order that exceptionally well-qualified personnel may be recruited and
10 retained, the Office of the Governor may exceed the maximum salary levels by
11 no more than twenty percent (20%) for no more than one-third (1/3) of the
12 positions authorized in the operation appropriation act after receiving
13 approval from the Arkansas Legislative Council or Joint Budget Committee.

14 The provisions of this section shall be in effect only from July 1, ~~2017~~
15 2018 through June 30, ~~2018~~ 2019.

16
17 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
18 authorized by this act shall be limited to the appropriation for such agency
19 and funds made available by law for the support of such appropriations; and
20 the restrictions of the State Procurement Law, the General Accounting and
21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
22 Procedures and Restrictions Act, or their successors, and other fiscal
23 control laws of this State, where applicable, and regulations promulgated by
24 the Department of Finance and Administration, as authorized by law, shall be
25 strictly complied with in disbursement of said funds.

27 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
28 Assembly that any funds disbursed under the authority of the appropriations
29 contained in this act shall be in compliance with the stated reasons for
30 which this act was adopted, as evidenced by the Agency Requests, Executive
31 Recommendations and Legislative Recommendations contained in the budget
32 manuals prepared by the Department of Finance and Administration, letters, or
33 summarized oral testimony in the official minutes of the Arkansas Legislative
34 Council or Joint Budget Committee which relate to its passage and adoption.

36 SECTION 8. EFFECTIVE DATE. This act is effective on and after July 1,
