18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. REAPPROPRIATION. There is hereby appropriated, to the		
21	Office of Attorney General, to be payable from the General Improvement Fund		
22	or its successor fund or fund accounts, for the Office of Attorney General		
23	the following:		
24	(A) Effective July 1, 2018, the balance of the appropriation provided		
25	in Item (A) of Section 1 of Act 350 of 2017, for personal services and		
26	operating expenses for staffing and implementing a Hot Line for reporting and		
27	data collection, in a	sum not to exceed	\$50,000.

29		URSEMENT CONTROLS. (A) No contract	•
30	-	obligations otherwise incurred in relation to the project or projects	
31	described herein in excess of the State Treasury funds actually available		
32	therefor as provided by law. Provided, however, that institutions and		
33	agencies listed herein shall have the authority to accept and use grants and		
34	donations including Federal funds, and to use its unobligated cash income or		
35	funds, or both available to it, for the purpose of supplementing the State		
36	Ireasury funds for fi	nancing the entire costs of the pro	oject or projects



enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 4. EFFECTIVE DATE. This act is effective on and after July 1,

2018.
