9 IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
10 HIGHER EDUCATION; AND FOR OTHER PURPOSES.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19
20 SECTION 1. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
21 GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas State
22 University, to be payable from the General Improvement Fund or its successor
23 fund or fund accounts, for the Arkansas State University the following:

24 (A) Effective July 1, 2018, the balance of the appropriation provided
25 in Item (G) of Section 1 of Act 702 of 2017, for construction, renovation,
26 maintenance, equipment, personal services and operating expenses of the
27 various institutions and entities of the Arkansas State University System, in
28 a sum not to exceed\$100,000.

29 (B) Effective July 1, 2018, the balance of the appropriation provided
30 in Item (A) of Section 1 of Act 842 of 2017, for construction, renovation,
31 maintenance, equipment, personal services and operating expenses of the
32 various institutions and entities of the Arkansas State University System, in
33 a sum not to exceed\$15,000,000.

34 (C) Effective July 1, 2018, the balance of the appropriation provided
35 in Item (B) of Section 1 of Act 842 of 2017, for construction of a College of
36 Engineering building, in a sum not to exceed\$4,000,000.



1 (D) Effective July 1, 2018, the balance of the appropriation provided
2 in Item (C) of Section 1 of Act 842 of 2017, for College of Education and
3 Communications restrooms renovation, in a sum not to exceed\$908,500.

4 (E) Effective July 1, 2018, the balance of the appropriation provided
5 in Item (D) of Section 1 of Act 842 of 2017, for Library HVAC system
6 renovation and modernization, in a sum not to exceed\$2,000,000.

7 (F) Effective July 1, 2018, the balance of the appropriation provided
8 in Item (E) of Section 1 of Act 842 of 2017, for Lab Sciences Lab and HVAC
9 System renovation and modernization, in a sum not to exceed\$1,291,500.

10 (G) Effective July 1, 2018, the balance of the appropriation provided
11 in Item (F) of Section 1 of Act 842 of 2017, for critical maintenance, in a
12 sum not to exceed\$1,840,000.

13 (H) Effective July 1, 2018, the balance of the appropriation provided
14 in Item (G) of Section 1 of Act 842 of 2017, for deferred maintenance, in a
15 sum not to exceed\$4,940,000.

16 (I) Effective July 1, 2018, the balance of the appropriation provided
17 in Item (H) of Section 1 of Act 842 of 2017, for the purchase, replacement,
18 and renewal of equipment and library holdings, in a sum not to exceed
19\$2,342,774.

20
21 SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
22 NCRC - V.C. KAYS HOUSE HERITAGE SITE. There is hereby appropriated, to the
23 Arkansas State University, to be payable from the Arkansas Natural and
24 Cultural Resources Grant and Trust Fund, for the Arkansas State University
25 the following:

26 (A) Effective July 1, 2018, the balance of the appropriation provided
27 in Section 23 of Act 234 of 2017, for the acquisition, management,
28 stewardship or preservation of state owned lands, historic sites, buildings,
29 structures or objects, in a sum not to exceed\$88,000.

30
31 SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
32 NCRC - KAIT - TV NEWS FILM COLLECTION. There is hereby appropriated, to the
33 Arkansas State University, to be payable from the Arkansas Natural and
34 Cultural Resources Grant and Trust Fund, for the Arkansas State University
35 the following:

36 (A) Effective July 1, 2018, the balance of the appropriation provided

1 in Section 23 of Act 234 of 2017, for the acquisition, management,
2 stewardship or preservation of state owned lands, historic sites, buildings,
3 structures or objects, in a sum not to exceed\$25,000.
4

5 SECTION 4. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - GENERAL
6 IMPROVEMENT. There is hereby appropriated, to the Arkansas Tech University,
7 to be payable from the General Improvement Fund or its successor fund or fund
8 accounts, for the Arkansas Tech University the following:

9 (A) Effective July 1, 2018, the balance of the appropriation provided
10 in Item (A) of Section 2 of Act 842 of 2017, for reroofing the Allied Health
11 Building on the Ozark Campus, in a sum not to exceed\$107,731.

12 (B) Effective July 1, 2018, the balance of the appropriation provided
13 in Item (B) of Section 2 of Act 842 of 2017, for technology upgrades,
14 including a partial renovation of Corley Hall and connecting the Ozark Campus
15 to the AREON, in a sum not to exceed\$5,832,533.

16 (C) Effective July 1, 2018, the balance of the appropriation provided
17 in Item (C) of Section 2 of Act 842 of 2017, for instructional technology in
18 labs for the Ozark Campus, in a sum not to exceed\$244,213.

19 (D) Effective July 1, 2018, the balance of the appropriation provided
20 in Item (D) of Section 2 of Act 842 of 2017, for construction of an academic
21 classroom facility, in a sum not to exceed\$2,367,467.

22 (E) Effective July 1, 2018, the balance of the appropriation provided
23 in Item (E) of Section 2 of Act 842 of 2017, for renovation of restrooms in
24 the Technology and Academic Support building on the Ozark Campus, in a sum
25 not to exceed\$120,589.

26 (F) Effective July 1, 2018, the balance of the appropriation provided
27 in Item (F) of Section 2 of Act 842 of 2017, for critical maintenance, in a
28 sum not to exceed\$300,000.

29 (G) Effective July 1, 2018, the balance of the appropriation provided
30 in Item (G) of Section 2 of Act 842 of 2017, for critical maintenance for the
31 Ozark Campus, in a sum not to exceed\$30,000.

32 (H) Effective July 1, 2018, the balance of the appropriation provided
33 in Item (H) of Section 2 of Act 842 of 2017, for deferred maintenance, in a
34 sum not to exceed\$2,460,000.

35 (I) Effective July 1, 2018, the balance of the appropriation provided
36 in Item (I) of Section 2 of Act 842 of 2017, for purchase, replacement, and

1 renewal of equipment and library holdings, in a sum not to exceed
2\$1,361,321.

3 (J) Effective July 1, 2018, the balance of the appropriation provided
4 in Item (J) of Section 2 of Act 842 of 2017, for deferred maintenance for the
5 Ozark Campus, in a sum not to exceed\$190,000.

6 (K) Effective July 1, 2018, the balance of the appropriation provided
7 in Item (K) of Section 2 of Act 842 of 2017, for purchase, replacement, and
8 renewal of equipment and library holdings at the Ozark Campus, in a sum not
9 to exceed\$149,510.

11 SECTION 5. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - NCRC -
12 RENOVATION OF WILLIAMSON HALL. There is hereby appropriated, to the Arkansas
13 Tech University, to be payable from the Arkansas Natural and Cultural
14 Resources Grant and Trust Fund, for the Arkansas Tech University the
15 following:

16 (A) Effective July 1, 2018, the balance of the appropriation provided
17 in Section 23 of Act 234 of 2017, for the acquisition, management,
18 stewardship or preservation of state owned lands, historic sites, buildings,
19 structures or objects, in a sum not to exceed\$600,000.

20

21 SECTION 6. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - GENERAL
22 IMPROVEMENT. There is hereby appropriated, to the Henderson State
23 University, to be payable from the General Improvement Fund or its successor
24 fund or fund accounts, for the Henderson State University the following:

25 (A) Effective July 1, 2018, the balance of the appropriation provided
26 in Item (A) of Section 3 of Act 842 of 2017, for construction of a HPER
27 building and renovation of the Wells Building, in a sum not to exceed
28\$3,000,000.

29 (B) Effective July 1, 2018, the balance of the appropriation provided
30 in Item (B) of Section 3 of Act 842 of 2017, for renovation of the Russell
31 Fine Arts Building, in a sum not to exceed\$3,000,000.

32 (C) Effective July 1, 2018, the balance of the appropriation provided
33 in Item (C) of Section 3 of Act 842 of 2017, for construction of a School of
34 Business building and renovation of Mooney Hall, in a sum not to exceed
35\$1,200,000.

16 (A) Effective July 1, 2018, the balance of the appropriation provided
17 in Section 23 of Act 234 of 2017, for the acquisition, management,
18 stewardship or preservation of state owned lands, historic sites, buildings,
19 structures or objects, in a sum not to exceed\$1,092,777.

20
21 SECTION 8. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - GENERAL
22 IMPROVEMENT. There is hereby appropriated, to the Southern Arkansas
23 University, to be payable from the General Improvement Fund or its successor
24 fund or fund accounts, for the Southern Arkansas University the following:

25 (A) Effective July 1, 2018, the balance of the appropriation provided
26 in Item (A) of Section 7 of Act 702 of 2017, for deferred maintenance
27 expenses, in a sum not to exceed\$11,329.

28 (B) Effective July 1, 2018, the balance of the appropriation provided
29 in Item (B) of Section 7 of Act 702 of 2017, for construction, renovation,
30 maintenance, critical maintenance, equipment, security enhancements,
31 technology upgrades/equipment and library resources, in a sum not to exceed

25 (A) Effective July 1, 2018, the balance of the appropriation provided
26 in Section 23 of Act 234 of 2017, for the acquisition, management,
27 stewardship or preservation of state owned lands, historic sites, buildings,
28 structures or objects, in a sum not to exceed\$400,000.

29
30 SECTION 10. REAPPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL
31 SCIENCES - GENERAL IMPROVEMENT. There is hereby appropriated, to the
32 University of Arkansas for Medical Sciences, to be payable from the General
33 Improvement Fund or its successor fund or fund accounts, for the University
34 of Arkansas for Medical Sciences the following:

35 (A) Effective July 1, 2018, the balance of the appropriation provided
36 in Item (A) of Section 5 of Act 842 of 2017, for upgrades to the Central

1 Building to meet code requirements, in a sum not to exceed\$4,200,000.

2 (B) Effective July 1, 2018, the balance of the appropriation provided
3 in Item (B) of Section 5 of Act 842 of 2017, for expansion of the Electronic
4 Health System to Primary Care Clinics managed by UAMS Regional Programs and
5 Specialty Clinics operating at the UAMS Northwest Campus, in a sum not to
6 exceed\$2,000,000.

7 (C) Effective July 1, 2018, the balance of the appropriation provided

24 agencies listed herein shall have the authority to accept and use grants and
25 donations including Federal funds, and to use its unobligated cash income or
26 funds, or both available to it, for the purpose of supplementing the State
27 Treasury funds for financing the entire costs of the project or projects
28 enumerated herein. Provided further, that the appropriations and funds
29 otherwise provided by the General Assembly for Maintenance and General
30 Operations of the agency or institutions receiving appropriation herein shall

7 which this act was adopted, as evidenced by the Agency Requests, Executive
8 Recommendations and Legislative Recommendations contained in the budget
9 manuals prepared by the Department of Finance and Administration, letters, or
10 summarized oral testimony in the official minutes of the Arkansas Legislative
11 Council or Joint Budget Committee which relate to its passage and adoption.

13 SECTION 26. EFFECTIVE DATE. This act is effective on and after July 1,
14 2018.
