AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE ARKANSAS
GEOLOGICAL SURVEY AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE ARKANSAS GEOLOGICAL SURVEY
REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - CAPITAL PROJECTS. There is hereby
appropriated, to the Arkansas Geological Survey, to be payable from the
General Improvement Fund or its successor fund or fund accounts, for the
Arkansas Geological Survey the following:

(A) Effective July 1, 2018, the balance of the appropriation provided
in Item (A) of Section 1 of Act 221 of 2017, for the Arkansas Geological
Survey Warehouse Roof replacement, in a sum not to exceed\$141,075.

(B) Effective July 1, 2018, the balance of the appropriation provided
in Item (B) of Section 1 of Act 221 of 2017, for the Arkansas Geological
Survey Building major maintenance, renovation or repair, in a sum not to
exceed\$35,000.

(C) Effective July 1, 2018, the balance of the appropriation provided
in Item (C) of Section 1 of Act 221 of 2017, for addition, renovation, or
replacement of the Geological Education Center, in a sum not to exceed
.....\$1,132,005.

SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor



1 obligations otherwise incurred in relation to the project or projects
2 described herein in excess of the State Treasury funds actually available
3 therefor as provided by law. Provided, however, that institutions and
4 agencies listed herein shall have the authority to accept and use grants and
5 donations including Federal funds, and to use its unobligated cash income or
6 funds, or both available to it, for the purpose of supplementing the State
7 Treasury funds for financing the entire costs of the project or projects
8 enumerated herein. Provided further, that the appropriations and funds
9 otherwise provided by the General Assembly for Maintenance and General
10 Operations of the agency or institutions receiving appropriation herein shall
11 not be used for any of the purposes as appropriated in this act.

12 (B) The restrictions of any applicable provisions of the State
13 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
14 Revenue Stabilization Law and any other applicable fiscal control laws of
15 this State and regulations promulgated by the Department of Finance and
16 Administration, as authorized by law, shall be strictly complied with in
17 disbursement of any funds provided by this act unless specifically provided
18 otherwise by law.

20 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
21 Assembly that any funds disbursed under the authority of the appropriations
22 contained in this act shall be in compliance with the stated reasons for
23 which this act was adopted, as evidenced by the Agency Requests, Executive
24 Recommendations and Legislative Recommendations contained in the budget
25 manuals prepared by the Department of Finance and Administration, letters, or
26 summarized oral testimony in the official minutes of the Arkansas Legislative
27 Council or Joint Budget Committee which relate to its passage and adoption.

29 SECTION 4. EFFECTIVE DATE. This act is effective on and after July 1,
30 2018.
