2	SECTION 1. DO NOT CODIFY. <u>Title</u> .							
3	This act shall be known and may be cited as the "Arkansas Works Program							
4	Enrollment Freeze Act of 2018".							
5								
6	SECTION 2. Arkansas Code Title 23, Chapter 61, Subchapter 10, is							
7	amended to add an additional section to read as follows:							
8	23-61-1010. Stop enrollment in the Arkansas Works Program — Require							
9	submittal of state Medicaid plan amendments or waivers.							
10	(a) On and after July 15, 2018, the Department of Human Services shall							
11	not approve new enrollment in the Arkansas Works Program created under this							
12	subchapter.							
13	(b) The department may renew enrollment for individuals currently							
14	enrolled in the program if the individuals meet and have continuously met all							
15	eligibility requirements and the Federal Medical Assistance Percentage for							
16	the enrollees does not drop below the percentages established by section							
17	1905(y) of the Social Security Act, 42 U.S.C. § 1396d, as existing on January							
18	1, 2018, or by the rules of the department.							
19	(c) The department shall amend the state Medicaid plan and file any							
20	and all necessary waivers with the Centers for Medicare and Medicaid Services							
21	to implement this section.							
22								
23	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the							
24	General Assembly of the State of Arkansas that new enrollment in the Arkansas							
25	Works Program should be stopped as soon as reasonably possible; that the							
26	program has grown to an unsustainable level and stopping enrollment is							
27	necessary to ensure the future solvency of the program; and that this act is							
28	immediately necessary to assist the Department of Human Services to							
29	efficiently conduct its duties. Therefore, an emergency is declared to exist,							
30	and this act being immediately necessary for the preservation of the public							
31	peace, health, and safety shall become effective on:							
32	(1) The date of its approval by the Governor;							
33	(2) If the bill is neither approved nor vetoed by the Governor,							
34	the expiration of the period of time during which the Governor may veto the							
35	bill; or							
36	(3) If the bill is vetoed by the Governor and the veto is							

1	overridden,	the	date	the	last	house	overrides	the	veto."
