36	amended to add additi	ional sections to read as follows:	

1	27-24-1428. Grand Lodge of Arkansas special license plate.		
2	(a) The Director of the Department of Finance and Administration shall		
3	create and issue a Grand Lodge of Arkansas special license plate in the		
4	manner and subject to the conditions provided for under this subchapter.		
5	(b) The Grand Lodge of Arkansas special license plate shall be:		
6	(1) Designed by the Department of Finance and Administration in		
7	consultation with the Grand Lodge of Arkansas, the ruling body of the		
8	Arkansas Masons; and		
9	(2) Numbered consecutively.		
10	(c) The procedures concerning costs for issuance under § 27-24-		
11	1404(c)(1)(A) shall apply.		
12	(d) The department shall issue a special license plate under this		
13	section to a motor vehicle owner upon:		
14	(1) Presentment of a current dues card issued to the motor		
15	vehicle owner by the Arkansas Masonic Lodge of Free and Accepted Masons		
16	showing he has paid his annual membership dues; and		
17	(2) Payment of:		
18	(A) The fee required by law for registration of the motor		
19	vehicle;		
20	(B)(i) Twenty-five dollars (\$25.00) to cover the design-		
21	use contribution.		
22	(ii) The design-use contribution shall be remitted		
23	monthly to The Most Worshipful Grand Lodge, Free and Accepted Masons of the		
24	State of Arkansas, and its Masonic Jurisdiction to be used exclusively to		
25	promote and support the Grand Lodge of Arkansas and the Arkansas Masons; and		
26	(C)(i) A handling and administrative fee of ten dollars		
27	<u>(\$10.00).</u>		
28	(ii) The handling and administrative fee of ten		
29	dollars (\$10.00) shall be:		
30	(a) Deposited into the State Central Services		
31	Fund for the benefit of the Revenue Division of the Department of Finance and		
32	Administration; and		
33	(b) Credited to the division as supplemental		
34	and in addition to all other funds that may be deposited for the benefit of		
35	the division.		
36	(iii) The handling and administrative fee shall not		

1	be considered or credited to the division as direct revenue.
2	(e)(1) A special license plate issued under this section may be
3	renewed annually or replaced under the procedures set out in § 27-24-1405.
4	(2) However, the division shall remit the fees collected under §
5	27-24-1405(b)(2) on a monthly basis to The Most Worshipful Grand Lodge, Free
6	and Accepted Masons of the State of Arkansas, and its Masonic Jurisdiction.

8	27-24-1429. Limitation on types of special interest license plates.
9	(a) The types of special interest license plates issued under this
10	subchapter by the Department of Finance and Administration are limited to the
11	total types of special interest license plates in existence on September 1,
12	<u>2019.</u>
13	(b) A new type of special interest license plate may be created and
14	issued under this subchapter only if an existing type of special interest
15	license plate is repealed.
