20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

36 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ATTORNEY
2 FEES. The disbursing officer of the appropriations provided for herein,
3 shall deposit all monies received by the Office of Attorney General as
4 attorney fees in the State Central Services Fund as direct revenues.

5 The provisions of this section shall be in effect only from July 1, ~~2018~~
6 2019 through June 30, ~~2019~~ 2020.

7

8 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
10 PROVISION. After receiving approval from the Chief Fiscal Officer of the
11 State, and prior review by the Arkansas Legislative Council or Joint Budget
12 Committee, the Office of Attorney General is authorized to transfer
13 appropriation from any line item authorized in the Operations Appropriation
14 of the Office of Attorney General in this Act to any other line item
15 authorized in the Operations Appropriation.

16 The provisions of this section shall be in effect only from July 1, ~~2018~~
17 2019 through June 30, ~~2019~~ 2020.

18

19 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FEES.
21 The Office of the Attorney General is hereby authorized to charge fees to
22 other governmental units in order to reimburse the Office of the Attorney
23 General for expenditures made on behalf of the other governmental units.
24 Such fees are to be deposited into the State Central Services Fund in the
25 State Treasury as a refund to expenditures.

26 The provisions of this section shall be in effect only from July 1, ~~2018~~
27 2019 through June 30, ~~2019~~ 2020.

28

29 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
31 TRANSFER. Immediately upon the effective date of this act, the Attorney
32 General shall deposit or transfer by check up to the sum of two million
33 dollars (\$2,000,000) from the unobligated cash funds of the Office of
34 Attorney General received from court orders or settlement agreements to the
35 State Central Services Fund.

36 The provisions of this section shall be in effect only from July 1, ~~2018~~

1 2019 through June 30, ~~2019~~ 2020.

2
3 SECTION 22. SPECIAL LANGUAGE. CODE AMENDMENT. Arkansas Code Title
4 20, Chapter 77, Subchapter 9, is amended to add an additional section to read
5 as follows:

6 20-77-912. Funds for investigations and prosecutions.

7 (a) Under this subchapter and the Medicaid Fraud Act, § 5-55-101 et
8 seq., the Attorney General or a prosecuting attorney is entitled to recover
9 reasonable and necessary expenses incurred during its investigations and
10 prosecutions.

11 (b) The Attorney General shall create and maintain accounts for these
12 funds.

13 (c) The federal share of these funds shall be returned to the United
14 States Government in accordance with the federal regulations governing the
15 Medicaid Fraud Control Unit.

16 (d) The remaining funds shall be retained and expended by the Attorney
17 General to defer the cost of future investigations and prosecutions conducted
18 by the Medicaid Fraud Control Unit.

19
20 SECTION 23. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
21 authorized by this act shall be limited to the appropriation for such agency
22 and funds made available by law for the support of such appropriations; and
23 the restrictions of the State Procurement Law, the General Accounting and
24 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
25 Procedures and Restrictions Act, or their successors, and other fiscal
26 control laws of this State, where applicable, and regulations promulgated by
27 the Department of Finance and Administration, as authorized by law, shall be
28 strictly complied with in disbursement of said funds.

29
30 SECTION 24. LEGISLATIVE INTENT. It is the intent of the General
31 Assembly that any funds disbursed under the authority of the appropriations
32 contained in this act shall be in compliance with the stated reasons for
33 which this act was adopted, as evidenced by the Agency Requests, Executive
34 Recommendations and Legislative Recommendations contained in the budget
35 manuals prepared by the Department of Finance and Administration, letters, or
36 summarized oral testimony in the official minutes of the Arkansas Legislative

1 Council or Joint Budget Committee which relate to its passage and adoption.

2

3 SECTION 25. EMERGENCY CLAUSE. It is found and determined by the
4 General Assembly, that the Constitution of the State of Arkansas prohibits
5 the appropriation of funds for more than a one (1) year period; that the
6 effectiveness of this Act on July 1, 2019 is essential to the operation of
7 the agency for which the appropriations in this Act are provided, and that in
8 the event of an extension of the legislative session, the delay in the
9 effective date of this Act beyond July 1, 2019 could work irreparable harm
10 upon the proper administration and provision of essential governmental
11 programs. Therefore, an emergency is hereby declared to exist and this Act
12 being necessary for the immediate preservation of the public peace, health
13 and safety shall be in full force and effect from and after July 1, 2019.
