22	SECTION 1. Arkansas Code § $27-24-1404(c)(1)$ , concerning the
23	application process for a special license plate decal and special license
24	plate, is amended to read as follows:
25	(c)(1)(A) If the request is approved, the director shall determine:
26	(i) The fee for the cost of <u>creating</u> a special
27	license plate, including without limitation the cost of:
28	(a) The initial order of a special license
29	plate created under this subchapter initial orders of new designs for special

7	received to cover the <del>cost of the initial orders of new designs for special</del>
8	license plates costs provided in subdivision (c)(l)(A)(i) of this section; or
9	(iii) The combination of subdivisions (c)(1)(A)(i)
10	and (ii) of this section that must be received <del>to cover the cost of the</del>
11	initial orders of new designs for special license plates by the department
12	for the creation of a special license plate.
13	(B)(i) The fee remitted under subdivision $(c)(1)(A)$ of
14	this section shall be deposited into the State Central Services Fund for the
15	benefit of the Revenue Division of the Department of Finance and
16	Administration.
17	(ii) The fee shall be credited as supplemental and
18	in addition to all other funds as may be deposited for the benefit of the
19	division.
20	(iii) The fee shall not be considered or credited to
21	the division as direct revenue.
22	(C) The fee required under subdivision (c)(1)(A) of this
23	section does not apply to a special license plate in existence before January
24	<u>1, 2019.</u>
