3	amended to add additional sections to read as follows:		
4	27-24-1428. Grand Lodge of Arkansas special license plate.		
5	(a) The Director of the Department of Finance and Administration shall		
6	create and issue a Grand Lodge of Arkansas special license plate in the		
7	manner and subject to the conditions provided for under this subchapter.		
8	(b) The Grand Lodge of Arkansas special license plate shall be:		
9	(1) Designed by the Department of Finance and Administration in		
10	consultation with the Grand Lodge of Arkansas, the ruling body of the		
11	Arkansas Masons; and		
12	(2) Numbered consecutively.		
13	(c) The procedures concerning costs for issuance under § 27-24-		
14	1404(c)(1)(A) shall apply.		
15	(d) The department shall issue a special license plate under this		
16	section to a motor vehicle owner upon:		
17	(1) Presentment of a current dues card issued to the motor		
18	vehicle owner by the Arkansas Masonic Lodge of Free and Accepted Masons		
19	showing he has paid his annual membership dues; and		
20	(2) Payment of:		
21	(A) The fee required by law for registration of the motor
