5	SECTION 2. Arkansas Code Title 6, Chapter 17, Subchapter 8, is amended
6	to add an additional section to read as follows:
7	6-17-813. Payroll deductions for union dues for firefighters, police
8	officers, and emergency first responders.
9	A school district employee who is also employed as a firefighter,
10	police officer, or emergency first responder for the state or a county or
11	municipality may request in writing a payroll deduction for union dues
12	related to the school district employee's role as a firefighter, police
13	officer, or emergency first responder.
14	
15	SECTION 3. Arkansas Code § 14-58-103(b)(1), concerning withholding of
16	union dues for municipal employees, is amended to read as follows:
17	(b)(1) Effective January 1, 2006, upon Upon receipt of a written
18	request signed by a full-time municipal employee who is a firefighter, police
19	officer, or emergency first responder and who is represented by a union or
20	professional association, the municipality shall withhold $\underline{\text{from the salary of}}$
21	the employee membership dues of the union or professional association related
22	to the employee's role as a firefighter, police officer, or emergency first
23	responder from the salary of the employee.
24	
25	SECTION 4. Arkansas Code § 19-4-1602(a)(7), concerning payroll
26	deductions for state employees, is amended to read as follows:
27	(7) Payment of union dues, when requested in writing by a state
28	or public employee who is a state, county, or municipal firefighter, police
29	officer, or emergency first responder for dues related to the employee's role
30	as a firefighter, police officer, or emergency first responder;
