| 21 | BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS: |

| 23 | SECTION 1. Arkansas Code § 24-4-607 is amended to read as follows: |
| 24 | 24-4-607. Redetermination of benefits. |
| 25 | (a)(1) Each July 1 the Arkansas Public Employees' Retirement System |
| 26 | $\frac{1}{2}$ shall $\frac{1}{2}$ redetermine the amount of each monthly benefit which has been |
| 27 | payable by the system for at least twelve (12) full calendar months. |
| 28 | (2) The redetermined amount shall be payable for the following |
| 29 | twelve (12) calendar months. |
| 30 | (b) $\underline{(1)}$ The redetermined amount shall be the amount of the benefit |
| 31 | payable as of the immediately preceding July 1 increased by $\underline{a\ \text{simple cost-of-}}$ |
| 32 | living adjustment that is no more than three percent (3%). |
| 33 | (2)(A) The redetermined amount shall not be less than the base |
| 34 | amount. |
| 35 | (B) As used in subdivision (b)(2)(A) of this |
| 36 | section, "base amount" means the amount of the benefit payable to a member |

| 19 | SECTION 2. EMERGENCY CLAUSE. It is found and determined by the |
| 20 | General Assembly of the State of Arkansas that the operations of the Arkansas |
| 21 | Public Employees' Retirement System must be able to meet the needs of its |
| 22 | members as anticipated by the General Assembly; that certain provisions of |
| 23 | the Arkansas Public Employees' Retirement System are in imminent need of |
| 24 | revision before the fiscal year begins on July 1, 2019; and that this act is |
| 25 | immediately necessary in order to maintain an orderly system of benefits for |
| 26 | the members of the Arkansas Public Employees' Retirement System. Therefore, |
| 27 | an emergency is declared to exist, and this act being necessary for the |
| 28 | preservation of the public peace, health, and safety shall become effective |
| 29 | on July 1, 2019. |
