25	SECTION 1. Arka	insas Code § 19-4-607(a), concerning th	ne review and
26	approval of annual ope	erations plans, is amended to read as f	follows:

35	SECTION 2. Arka	nsas Code § 19-4-607(d), concerning th	ne review and
36	approval of annual ope	erations plans, is amended to read as f	follows:

1	(d) The For each annual operations plan submitted by a state agency		
2	other than the elected constitutional officers, the legislative branch and		
3	its staff offices, the judicial branch and its staff offices, the Arkansas		
4	Department of Transportation, the Office of the Arkansas Lottery, and the		
5	Arkansas State Game and Fish Commission, the Chief Fiscal Officer of the		
6	State shall:		
7	(1) Review each annual operations plan to determine that:		
8	(A) It is consistent with the policy decisions of the		
9	General Assembly and the Governor;		
10	(B) Appropriations and funding have been provided by the		
11	General Assembly;		
12	(C) It reflects proper planning and efficient management		
13	methods; and		
14	(D) Appropriations and funding have been made for the		
15	planned purpose and will not be exhausted before the end of the fiscal year;		
16	and		
17	(2)(A)(i) Approve the annual operations plan if he or she is		
18	satisfied that it meets all requirements.		
19	(ii) Otherwise, he or she shall require necessary		
20	revisions of the annual operations plan in whole or in part.		
21	(B) However, nothing in this section shall be construed to		
22	allow the Chief Fiscal Officer of the State to substitute his or her		
23	individual judgment as to the operation or necessity of any program of any		
24	state agency for the judgment of the executive head or board or commission		
25	charged with the responsibility for the operation and control of that agency.		
26			
27	SECTION 3. Arkansas Code § 19-4-801(2)(B), concerning exclusions from		
28	the definition of "state agency" for purposes of the laws related to the		
29	expenditure of cash funds, is amended to read as follows:		
30	(B) "State agency" shall not include the:		
31	(i) Governor;		
32	(ii) Secretary of State;		
33	(iii) Attorney General;		
34	(iv) Treasurer of State;		
35	(v) Auditor of State;		
36	(vi) Commissioner of State Lands;		

1	(vii) Supreme Court and its justices;
2	(viii) Circuit courts and circuit judges;
3	(ix)(ii) Prosecuting attorneys; and
4	(x) Arkansas State Came and Fish Commission;
5	(xi) Arkansas Department of Transportation;
6	(xii)(a)(iii)(a) Office of the Arkansas Lottery.
7	(b) However, the office shall be considered a
8	state agency for the purposes of § 19-4-810 et seq.;
9	(xiii) General Assembly; and
10	(xiv) Respective staffs of the officers and agencies
11	listed in this subdivision (2)(B).
