6	(e) The court may require the petitioner to pay the opposing party's		
7	attorney's fee if the court determines the case to be frivolous and without		
8	merit.		
9	(f) This section does not apply to dependency-neglect proceedings		
10	conducted under the Arkansas Juvenile Code of 1989, § 9-27-301 et seq.
