25	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27	SECTION 1. Arkansas Code § 25-19-105(b), concerning exemptions to the
28	document disclosure requirements of the Arkansas Freedom of Information Act
29	of 1967, is amended to add an additional subdivision to read as follows:
30	(24)(A) When the custodian is a governmental entity that has
31	knowledge of the individual's assistance as described in subdivisions
32	(b)(24)(A)(i)-(iv) of this section, records containing information that could
33	reasonably be used to identify an individual who is assisting or has assisted
34	a governmental entity in one (1) or more investigations, whether open or
35	closed, of matters that are criminal in nature, if:
36	(i) The individual is a confidential informant;

1	(ii) The individual is a confidential source;
2	
3	(iii) The individual's assistance is or was provided under
4	an assurance of confidentiality; or
5	(iv) The individual's assistance was not provided under an
6	assurance of confidentiality, and disclosure of the individual's identity
7	could reasonably be expected to endanger the life or physical safety of the
8	individual or a member of the individual's family within the first degree of
9	consanguinity.
10	(B) As used in this subdivision (b)(24), "information that
11	could reasonably be used to identify an individual" includes the following:
12	(i) The individual's name;
13	(ii) The individual's date of birth;
14	(iii) A physical description of the individual that
15	could reasonably be used to identify him or her;
16	(iv) The individual's Social Security number,
17	driver's license number, or other government-issued number specific to him or
18	<u>her;</u>
19	(v) The individual's work or personal contact
20	information; and
21	(vi) Any other information about the individual that
22	could reasonably be used to identify the individual.
