AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is hereby appropriated, to the Arkansas Northeastern College, to be payable from the Development and Enhancement Fund, for the Arkansas Northeastern College the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (A) of Section 1 of Act 10 of 2018, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Workforce Training Building, in a sum not to exceed\$1,850,000.

(B) Effective July 1, 2019, the balance of the appropriation provided in Item (B) of Section 1 of Act 10 of 2018, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Nursing and Allied Health Building in Paragould, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2019, the balance of the appropriation provided in Item (C) of Section 1 of Act 10 of 2018, for critical maintenance, in a sum not to exceed\$350,000.



(D) Effective July 1, 2019, the balance of the appropriation provided in Item (D) of Section 1 of Act 10 of 2018, for deferred maintenance, in a sum not to exceed\$360,000.

(E) Effective July 1, 2019, the balance of the appropriation provided in Item (E) of Section 1 of Act 10 of 2018, for repair or replacement of equipment and library holdings, in a sum not to exceed\$138,225.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There is hereby appropriated, to the Arkansas State University - Beebe, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Beebe the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (B) of Section 2 of Act 10 of 2018, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an IT Services Data Center, in a sum not to exceed\$2,000,000.

(B) Effective July 1, 2019, the balance of the appropriation provided in Item (C) of Section 2 of Act 10 of 2018, for renovations of State Hall, in a sum not to exceed\$1,375,000.

(C) Effective July 1, 2019, the balance of the appropriation provided in Item (D) of Section 2 of Act 10 of 2018, for critical maintenance, in a sum not to exceed\$110,000.

(D) Effective July 1, 2019, the balance of the appropriation provided in Item (E) of Section 2 of Act 10 of 2018, for deferred maintenance, in a sum not to exceed\$1,070,000.

(E) Effective July 1, 2019, the balance of the appropriation provided in Item (F) of Section 2 of Act 10 of 2018, for repair or replacement of equipment and library holdings, in a sum not to exceed\$445,250.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH. There is hereby appropriated, to the Arkansas State University - Mid-South, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Mid-South the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (B) of Section 3 of Act 10 of 2018, for upgrade and replacement of Classroom Instructional Technology Equipment, in a sum not to exceed

.....\$102,000.

(B) Effective July 1, 2019, the balance of the appropriation provided in Item (C) of Section 3 of Act 10 of 2018, for critical maintenance, in a sum not to exceed\$20,000.

(C) Effective July 1, 2019, the balance of the appropriation provided in Item (D) of Section 3 of Act 10 of 2018, for deferred maintenance, in a sum not to exceed\$460,000.

(D) Effective July 1, 2019, the balance of the appropriation provided in Item (E) of Section 3 of Act 10 of 2018, for repair or replacement of equipment and library holdings, in a sum not to exceed\$159,060.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.
There is hereby appropriated, to the Arkansas State University - Mountain Home, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Mountain Home the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (A) of Section 4 of Act 10 of 2018, for acquisition and renovation of an Occupational Technical Center, in a sum not to exceed\$1,850,000.

(B) Effective July 1, 2019, the balance of the appropriation provided in Item (B) of Section 4 of Act 10 of 2018, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Health and Wellness Center, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2019, the balance of the appropriation provided in Item (C) of Section 4 of Act 10 of 2018, for critical maintenance, in a sum not to exceed\$90,000.

(D) Effective July 1, 2019, the balance of the appropriation provided in Item (D) of Section 4 of Act 10 of 2018, for deferred maintenance, in a sum not to exceed\$220,000.

(E) Effective July 1, 2019, the balance of the appropriation provided in Item (E) of Section 4 of Act 10 of 2018, for repair or replacement of equipment and library holdings, in a sum not to exceed\$162,705.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.
There is hereby appropriated, to the Arkansas State University - Newport, to be payable from the Development and Enhancement Fund, for the Arkansas State

University - Newport the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (A) of Section 5 of Act 10 of 2018, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a STEM Classroom/Lab Building on the Jonesboro Campus, in a sum not to exceed\$1,000,000.

(B) Effective July 1, 2019, the balance of the appropriation provided in Item (B) of Section 5 of Act 10 of 2018, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an Administration Building on the Newport Campus, in a sum not to exceed\$750,000.

(C) Effective July 1, 2019, the balance of the appropriation provided in Item (C) of Section 5 of Act 10 of 2018, for renovation of a classroom building to provide a Transportation Tech Building on the Newport Campus, in a sum not to exceed\$547,500.

(D) Effective July 1, 2019, the balance of the appropriation provided in Item (D) of Section 5 of Act 10 of 2018, for remodel of the Main Building on the Jonesboro Campus, in a sum not to exceed\$552,500.

(E) Effective July 1, 2019, the balance of the appropriation provided in Item (E) of Section 5 of Act 10 of 2018, for critical maintenance, in a sum not to exceed\$20,000.

(F) Effective July 1, 2019, the balance of the appropriation provided in Item (F) of Section 5 of Act 10 of 2018, for deferred maintenance, in a sum not to exceed\$340,000.

(G) Effective July 1, 2019, the balance of the appropriation provided in Item (G) of Section 5 of Act 10 of 2018, for repair or replacement of equipment and library holdings, in a sum not to exceed\$264,730.

SECTION 6. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is hereby appropriated, to the Black River Technical College, to be payable from the Development and Enhancement Fund, for the Black River Technical College the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (A) of Section 6 of Act 10 of 2018, for Student Information System upgrades, in a sum not to exceed\$1,062,000.

(B) Effective July 1, 2019, the balance of the appropriation provided

1 in Item (B) of Section 6 of Act 10 of 2018, for the renovation of the "A" and
2 "B" Buildings, in a sum not to exceed\$157,500.

3 (C) Effective July 1, 2019, the balance of the appropriation provided
4 in Item (C) of Section 6 of Act 10 of 2018, for the construction of a storage
5 building for Fire Science Program truck and equipment, in a sum not to exceed
6\$157,500.

13 exceed\$90,000.

14 (F) Effective July 1, 2019, the balance of the appropriation provided
15 in Item (F) of Section 6 of Act 10 of 2018, for construction, renovation,
16 maintenance, critical maintenance, equipment, security enhancements,
17 technology upgrades/equipment and library resources of a Technical Education
18 Building, in a sum not to exceed\$1,167,000.

19 (G) Effective July 1, 2019, the balance of the appropriation provided
20 in Item (G) of Section 6 of Act 10 of 2018, for renovation of the Randolph
21 County Development Center, in a sum not to exceed\$162,000.

22 (H) Effective July 1, 2019, the balance of the appropriation provided

24 sum not to exceed\$10,000.

25 (I) Effective July 1, 2019, the balance of the appropriation provided
26 in Item (I) of Section 6 of Act 10 of 2018, for deferred maintenance, in a
27 sum not to exceed\$390,000.

28 (J) Effective July 1, 2019, the balance of the appropriation provided
29 in Item (J) of Section 6 of Act 10 of 2018, for repair or replacement of
30 equipment and library holdings, in a sum not to exceed\$201,595.

33 appropriated, to the College of The Ouachitas, to be payable from the
34 Development and Enhancement Fund, for the College of The Ouachitas the

36 (A) Effective July 1, 2019, the balance of the appropriation provided

1 in Item (A) of Section 7 of Act 10 of 2018, for construction, renovation,
 2 maintenance, critical maintenance, equipment, security enhancements,
 3 technology upgrades/equipment and library resources of the Health/Science
 4 Technology Building, in a sum not to exceed\$1,600,000.

5 (B) Effective July 1, 2019, the balance of the appropriation provided
 6 in Item (B) of Section 7 of Act 10 of 2018, for improvements in technology
 7 infrastructure, in a sum not to exceed\$250,000.

19 (F) Effective July 1, 2019, the balance of the appropriation provided

 23 SECTION 8. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE
 24 UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Cossatot
 25 Community College of the University of Arkansas, to be payable from the
 26 Development and Enhancement Fund, for the Cossatot Community College of the
 27 University of Arkansas the following:

28 (A) Effective July 1, 2019, the balance of the appropriation provided
 29 in Item (A) of Section 8 of Act 10 of 2018, for technology upgrades, in a sum
 30 not to exceed\$600,000.

31 (B) Effective July 1, 2019, the balance of the appropriation provided
 32 in Item (B) of Section 8 of Act 10 of 2018, for Heating, Ventilation, and Air
 33 Conditioning replacement for the Leeper Building, in a sum not to exceed
 34\$58,000.

35 (C) Effective July 1, 2019, the balance of the appropriation provided
 36 in Item (C) of Section 8 of Act 10 of 2018, for construction, renovation,

1 maintenance, critical maintenance, equipment, security enhancements,
 2 technology upgrades/equipment and library resources of the Student Commons,

 26 technology upgrades/equipment and library resources, in a sum not to exceed
 27\$250,000.

28 (B) Effective July 1, 2019, the balance of the appropriation provided
 29 in Item (B) of Section 10 of Act 10 of 2018, for deferred maintenance, in a
 30 sum not to exceed\$150,000.

31 (C) Effective July 1, 2019, the balance of the appropriation provided
 32 in Item (C) of Section 10 of Act 10 of 2018, for renovation of technology
 33 infrastructure and systems, in a sum not to exceed\$363,500.

25 bathroom, in a sum not to exceed\$160,000.

 10 SECTION 25. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
 11 obligations otherwise incurred in relation to the project or projects
 12 described herein in excess of the State Treasury funds actually available
 13 therefor as provided by law. Provided, however, that institutions and
 14 agencies listed herein shall have the authority to accept and use grants and
 15 donations including Federal funds, and to use its unobligated cash income or
 16 funds, or both available to it, for the purpose of supplementing the State
 17 Treasury funds for financing the entire costs of the project or projects
 18 enumerated herein. Provided further, that the appropriations and funds
 19 otherwise provided by the General Assembly for Maintenance and General
 20 Operations of the agency or institutions receiving appropriation herein shall
 21 not be used for any of the purposes as appropriated in this act.

22 (B) The restrictions of any applicable provisions of the State
 23 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
 24 Revenue Stabilization Law and any other applicable fiscal control laws of
 25 this State and regulations promulgated by the Department of Finance and
 26 Administration, as authorized by law, shall be strictly complied with in
 27 disbursement of any funds provided by this act unless specifically provided
 28 otherwise by law.

29
 30 SECTION 26. LEGISLATIVE INTENT. It is the intent of the General
 31 Assembly that any funds disbursed under the authority of the appropriations
 32 contained in this act shall be in compliance with the stated reasons for
 33 which this act was adopted, as evidenced by the Agency Requests, Executive
 34 Recommendations and Legislative Recommendations contained in the budget
 35 manuals prepared by the Department of Finance and Administration, letters, or
 36 summarized oral testimony in the official minutes of the Arkansas Legislative

1 Council or Joint Budget Committee which relate to its passage and adoption.

2
3 SECTION 27. EMERGENCY CLAUSE. It is found and determined by the
4 General Assembly, that the Constitution of the State of Arkansas prohibits
5 the appropriation of funds for more than a one (1) year period; that the
6 effectiveness of this Act on July 1, 2019 is essential to the operation of
7 the agency for which the appropriations in this Act are provided, and that in
8 the event of an extension of the legislative session, the delay in the
9 effective date of this Act beyond July 1, 2019 could work irreparable harm
10 upon the proper administration and provision of essential governmental
11 programs. Therefore, an emergency is hereby declared to exist and this Act
12 being necessary for the immediate preservation of the public peace, health
13 and safety shall be in full force and effect from and after July 1, 2019.
