10	4-29-503. Application of the Arkansas Business Corporation Act of
11	<u>1987.</u>
12	(a) The Arkansas Business Corporation Act of 1987, § 4-27-101 et seq.,
13	is applicable to a chiropractic corporation and the organization of a
14	chiropractic corporation, except that the number of incorporators of a
15	chiropractic corporation shall be one (1) or more, and they shall enjoy the
16	powers and privileges and be subject to the duties, restrictions, and
17	liabilities of other corporations, except so far as the same may be limited
18	or enlarged by this subchapter.
19	(b) If this subchapter conflicts with the Arkansas Business
20	Corporation Act of 1987, § 4-27-101 et seq., this subchapter shall take
21	precedence.
22	
23	4-29-504. Physician-patient relationship unaltered.
24	This subchapter does not alter any law applicable to the relationship
25	between a chiropractic physician providing chiropractic services and a person
26	receiving the services, including liability arising out of the services.
27	
28	4-29-505. Formation of chiropractic corporation — Employee licensing
29	required.
30	(a) One (1) or more persons licensed under the Arkansas Chiropractic
31	Practices Act, § 17-81-101 et seq., § 17-81-201 et seq., and § 17-81-301 et
32	seq., may associate to form a chiropractic corporation under the Arkansas
33	Business Corporation Act of 1987, § 4-27-101 et seq., for the establishment
34	of a chiropractic corporation.
35	(b) Chiropractic treatment, consultation, or advice may be given by
36	employees of the chiroprectic corporation only if they are licensed under the

Arkansas Chiropractic Practices Act, § 17-81-101 et seq., § 17-81-201 et 1 2 seq., and § 17-81-301 et seq. 3 4 4-29-506. Corporate name. (a)(1) The corporate name of the chiropractic corporation may contain 5 6 the names of one (1) or more of the shareholders. 7 (2) However, the name of a person who is a shareholder but is 8 not employed by the chiropractic corporation shall not be included in the 9 corporate name, except that the name of a deceased shareholder may continue 10 to be included in the corporate name for one (1) year following the date of 11 death of the deceased shareholder. 12 (b) The corporate name shall end with the word "Chartered", or the 13 word "Limited", or the abbreviation "Ltd.", or the words "Professional 14 Association", or the abbreviation "P.A." 15 16 4-29-507. Officers, directors, and shareholders. 17 (a) All of the officers, directors, and shareholders of a chiropractic 18 corporation subject to this subchapter shall at all times be persons licensed 19 under the Arkansas Chiropractic Practices Act, § 17-81-101 et seq., § 17-81-20 201 et seq., and § 17-81-301 et seq. 21 (b) A person who is not licensed as described in subsection (a) of 22 this section shall not have any part in the ownership, management, or control 23 of the chiropractic corporation and shall not be given a proxy to vote. 24 25 4-29-508. Employees. 26 An employee licensed under the Arkansas Chiropractic Practices Act, § 27 17-81-101 et seq., § 17-81-201 et seq., and § 17-81-301 et seq., who is 28 employed by a chiropractic corporation subject to this subchapter shall 29 remain subject to reprimand or discipline for his or her conduct under the 30 Arkansas Chiropractic Practices Act, § 17-81-101 et seq., § 17-81-201 et 31 seq., and § 17-81-301 et seq. 32 4-29-509. Certificate of registration — Issuance and renewal. 33 34 (a) A chiropractic corporation shall not open, operate, or maintain an 35 establishment providing chiropractic services for any of the purposes stated 36 in § 4-29-505 without a certificate of registration from the Arkansas State

1	Board of Chiropractic Examiners.
2	(b) An application for a certificate of registration shall be made to
3	the board in writing and shall contain the name and address of the
4	chiropractic corporation and other information as may be required by the
5	board.
6	(c)(1) Upon receipt of the application, the board shall make an
7	investigation of the chiropractic corporation.
8	(2) If the board finds that the chiropractic corporation's
9	incorporators, officers, directors, and shareholders are licensed under the
10	Arkansas Chiropractic Practices Act, § 17-81-101 et seq., § 17-81-201 et
11	seq., and § 17-81-301 et seq., and if no disciplinary action is pending
12	before the board against any of the incorporators, officers, directors, or
13	shareholders and if the board determines that the chiropractic corporation
14	will be conducted in compliance with law and the rules of the board, the
15	board shall issue, and may require a maximum registration fee of twenty-five
16	dollars (\$25.00), a certificate of registration which shall remain effective
17	until January 1 following the date of registration.
18	(d) Upon written application of the holder, the board shall renew the
19	certificate of registration annually and shall require a maximum renewal fee
20	of ten dollars (\$10.00), if the board finds that the chiropractic corporation
21	has complied with the rules of the board and this subchapter.
22	(e) The certificate of registration shall be conspicuously posted upon
23	the premises to which it is applicable.
24	(f) In the event of a change of location of the registered
25	chiropractic corporation, the board, according to the rules of the board,
26	shall amend the certificate of registration so that it applies to the new
27	location.
28	(g) A certificate of registration is not transferable.
29	
30	4-29-510. Certificate of registration — Suspension or revocation.
31	(a) The Arkansas State Board of Chiropractic Examiners may suspend or
32	revoke any certificate of registration for any of the following reasons:
33	(1) If an officer, director, shareholder, or employee of the
34	chiropractic corporation has his or her license to practice chiropractic

not promptly removed or discharged by the chiropractic corporation;

suspended or revoked and the officer, director, shareholder, or employee is

1	(2) If an officer, director, shareholder, or employee of the
2	chiropractic corporation is found to have engaged in unethical professional
3	conduct and the officer, director, shareholder, or employee is not promptly
4	removed or discharged by the chiropractic corporation;
5	(3) The death of the last remaining shareholder; or
6	(4) Upon finding that the holder of a certificate of
7	registration has failed to comply with this subchapter or the rules
8	prescribed by the board.
9	(b)(1) Before any certificate of registration is suspended or revoked,
10	the holder shall be given written notice of the proposed action and the
11	reasons for the proposed action and shall be given a public hearing by the
12	board with the right to produce testimony concerning the charges submitted by
13	the board.
14	(2) The notice shall also state the place and date of the
15	hearing, which shall be at least five (5) days after service of the notice.
16	
17	4-29-511. Certificate of registration — Appeal from denial,
18	suspension, or revocation.
19	(a) A chiropractic corporation whose application for a certificate of
20	registration has been denied or whose certificate of registration has been
21	suspended or revoked may appeal to the Pulaski County Circuit Court within
22	thirty (30) days after notice of the action by the Arkansas State Board of
23	Chiropractic Examiners.
24	(b) The court shall inquire into the cause of the board's action and
25	may affirm or reverse the decision and order a further hearing by the board
26	or may order the board to grant the appellant a certificate of registration.
27	(c) An appeal shall be made in the manner provided by law.
28	(d)(1) Notice of appeal shall be served upon the Secretary of the
29	Arkansas State Board of Chiropractic Examiners by serving a copy of the
30	notice on the secretary within thirty (30) days after the board has notified
31	the chiropractic corporation of its decision.
32	(2) Service of process may be made by registered or certified
33	mail.
34	
35	4-29-512. Shares of deceased or disqualified shareholder — Price.
36	(a) If the articles of incorporation or bylaws of a chiropractic

1	corporation subject to this subchapter fail to state a price or a method of
2	determining a fixed price at which the chiropractic corporation or its
3	shareholders may purchase the shares of a deceased shareholder or a
4	shareholder who is no longer qualified to own shares in the chiropractic
5	corporation, the price for the shares shall be set at the book value as of
6	the end of the month immediately preceding the death or disqualification of
7	the shareholder.
8	(b) Book value shall be determined from the books and records of the
9	chiropractic corporation according to the regular method of accounting used
10	by the chiropractic corporation.
11	
12	4-29-513. Foreign chiropractic corporation — Certificate of
13	registration - Governance - Licensure.
14	(a) If a foreign chiropractic corporation complies with this
15	subchapter, the Arkansas State Board of Chiropractic Examiners may issue a
16	certificate of registration to the foreign chiropractic corporation.
17	(b) A person who is not licensed to practice chiropractic shall not
18	participate in the ownership, management, or control of a foreign
19	chiropractic corporation.
20	(c) A proxy to vote shares of a foreign chiropractic corporation shall
21	not be given to a person who is not licensed to practice chiropractic.
22	(d) A chiropractic physician who is affiliated with a foreign
23	chiropractic corporation shall obtain a license to practice chiropractic from
24	the board before practicing chiropractic in Arkansas.
