22	SECTION 1. Arkansas Code § 7-4-112 is amended to read as follows:	
23	7-4-112. Compensation of election officials.	
24	(a) The Except as provided under subsection (c) of this section, an	
25	election officials official shall receive a minimum of the prevailing federa	al
26	minimum wage for holding an election, or such greater amount as may be	
27	appropriated.	
28	(b) In addition, Except as provided in subsection (c) and in addition	<u>n</u>
29	to compensation under subsection (a) of this section, each election official	1
30	carrying election materials to and from the polling sites shall be allowed	
31	mileage at such rate as may be appropriated but not to exceed the rate	
32	prescribed for state employees in state travel regulations.	
33	(c)(l) An election official may work as a volunteer without pay or	
34	reimbursement as specified by the election official under this section if the	<u>ne</u>
35	election official signs an affidavit prescribed by the State Board of	
36	Election Commissioners stating that he or she does not wish to receive:	

1	(A) Compensation for his or her work as an election
2	official; or
3	(B) Reimbursement for mileage accrued in the course of his
4	or her work as an election official.
5	(2) An election official may choose not to receive compensation
6	or reimbursement, or both.
7	(3)(A) An election official who signs the affidavit indicating
8	that he or she does not wish to be compensated or reimbursed shall not be
9	compensated with money or anything of value for his or her work as an
10	election official.
11	(B) Any paperwork or document required by the student
12	election official's school to verify his or her assistance is not
13	compensation or reimbursement under this section.
