Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 18 19 Assembly, that funds provided by the General Assembly for the operations of 20 the Northwest Arkansas Community College are, due to unforeseen 21 circumstances, insufficient for the Northwest Arkansas Community College to 22 continue to provide essential governmental services; that the provisions of 23 this act will provide the necessary monies for the Northwest Arkansas 24 Community College to continue such services; and that a delay in the 25 effective date of this Act could work irreparable harm upon the proper 26 administration and provision of essential governmental programs. Therefore, 27 an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in 28 29 full force and effect from and after the date of its passage and approval. 30 If the bill is neither approved nor vetoed by the Governor, it shall 31 become effective on the expiration of the period of time during which the
