For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES
FOR THE NORTHWEST ARKANSAS COMMUNITY COLLEGE WHICH
SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS
APPROPRIATED BY ACT 188 OF 2018; AND FOR OTHER
PURPOSES.

Subtitle

AN ACT FOR THE NORTHWEST ARKANSAS
COMMUNITY COLLEGE SUPPLEMENTAL
APPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby
appropriated, to the Northwest Arkansas Community College, to be payable from
the Northwest Arkansas Community College Fund, for personal services of the
Northwest Arkansas Community College which shall be supplemental and in
addition to those funds appropriated in Section 3 of Act 188 of 2018, the
following:

SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
authorized by this act shall be limited to the appropriation for such agency
and funds made available by law for the support of such appropriations; and



1 the restrictions of the State Procurement Law, the General Accounting and
2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
3 Procedures and Restrictions Act, the Higher Education Expenditures
4 Restrictions Act, or their successors, and other fiscal control laws of this
5 State, where applicable, and regulations promulgated by the Department of
6 Finance and Administration, as authorized by law, shall be strictly complied
7 with in disbursement of said funds.

9 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
10 Assembly that any funds disbursed under the authority of the appropriations
11 contained in this act shall be in compliance with the stated reasons for
12 which this act was adopted, as evidenced by the Agency Requests, Executive
13 Recommendations and Legislative Recommendations contained in the budget
14 manuals prepared by the Department of Finance and Administration, letters, or
15 summarized oral testimony in the official minutes of the Arkansas Legislative
16 Council or Joint Budget Committee which relate to its passage and adoption.

18 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
19 Assembly, that funds provided by the General Assembly for the operations of
20 the Northwest Arkansas Community College are, due to unforeseen
21 circumstances, insufficient for the Northwest Arkansas Community College to
22 continue to provide essential governmental services; that the provisions of
23 this act will provide the necessary monies for the Northwest Arkansas
24 Community College to continue such services; and that a delay in the
25 effective date of this Act could work irreparable harm upon the proper
26 administration and provision of essential governmental programs. Therefore,
27 an emergency is hereby declared to exist and this Act being necessary for the
28 immediate preservation of the public peace, health and safety shall be in
29 full force and effect from and after the date of its passage and approval.

30 If the bill is neither approved nor vetoed by the Governor, it shall
31 become effective on the expiration of the period of time during which the
32 Governor may veto the bill. If the bill is vetoed by the Governor and the
33 veto is overridden, it shall become effective on the date the last house
34 overrides the veto.
