- 3 (2) A municipal firefighter shall be disciplined only for
- 4 <u>violation of policies reasonably related to the orderly, safe, and efficient</u>

- 7 fair and consistent manner and only after a fair and objective investigation
- 8 that demonstrates substantial proof or evidence that the municipal firefighter

- 32 limitation off-duty employment, personal relationships, domicile, or
- 33 religious observances.
- 34 (i) A municipal fire department shall not limit the size of an
- 35 applicant pool for positions within the municipal fire department.
