- (c)(1) Except as provided in subdivision (c)(2) of this section, the benefits shall be paid totally from state funds appropriated for these benefits. The funds shall not be reimbursed by a transfer or charging the funds against any state funds allocated for turnback to cities or counties or distributed to any other state department agency fund account other than the Arkansas State Claims Commission fund accounts and the Miscellaneous
- 8 (2)(A) Seventy-five thousand dollars (\$75,000) of the one 9 hundred fifty thousand dollars (\$150,000) provided in subdivision (c)(1) of 10 this section shall be paid by the appropriate state department agency fund 11 account.

- 12 (B) The appropriate state department agency shall transfer 13 the necessary funds to the Arkansas State Claims Commission fund accounts for 14 payment.
 - (d) The additional benefits provided in this section shall be paid to the designated beneficiary, surviving spouse, surviving children, or surviving parents qualified recipient in three (3) four (4) equal annual payments, the first of which shall be paid immediately upon entry of the order awarding the benefits, and the next three (3) payments shall be paid in July of the next three fiscal year years after the date of the original order of the Arkansas State Claims Commission establishing entitlement to additional payments and annually thereafter.
 - (e) Determination of eligibility for the additional payments provided in this section shall be made by the Arkansas State Claims Commission in accordance with Arkansas State Claims Commission rules and procedures.
 - (f)(1) A person who claims a benefit as a qualified recipient under this section to which the beneficiaries of a deceased person are entitled shall submit a notarized affidavit provided by the Arkansas State Claims Commission that:

 32 (B) Discloses the existence of any last will and testament
