23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKAN	ISAS:

25	SECTION 1. Arkansas Code Title 9, Chapter 32, Subcha	apter l, is amended
26	to add an additional section to read as follows:	
27	9-32-101. Collaboration of state agencies to form an	nd implement child
28	abduction response team.	
29	(a)(l) The following agencies shall collaborate in a	multi-agency
30	effort to rescue abducted or endangered children, implement	a child abduction
31	response team, and allocate the respective resources of each	ch agency to cases
32	involving missing or endangered children:	
33	(A) Attorney General;	
34	(B) Department of Arkansas State Polices	_
35	(C) Department of Correction;	
36	(D) Department of Human Services;	

1	(E) Arkansas Natural Resources Commission;
2	(F) Arkansas Department of Emergency Management;
3	(G) Arkansas Department of Transportation; and
4	(H) Parole Board.
5	(2) Each agency listed under subsection (a) of this section
6	shall:
7	(A) Execute a memorandum of understanding concerning the
8	guidelines for the implementation of a child abduction response team; and
9	(B) Respectively coordinate the available resources of the
10	agency to implement the child abduction response team and adhere to the
11	executed memorandum of understanding.
12	(b) The Department of Arkansas State Police shall:
13	(1) Assemble and coordinate a child abduction response team; and
14	(2) Ensure that the agencies listed under subsection (a) of this
15	section work in partnership to:
16	(A) Respond to child abduction incidents;
17	(B) Train child abduction response team members; and
18	(C) Provide preventative measures.
19	(c) The Arkansas Department of Emergency Management shall support the
20	coordination of the child abduction response team by establishing a unified
21	command and coordinating additional state resources as needed in a manner
22	that is consistent with the operation plans of the Arkansas Department of
23	Emergency Management.

25	SECTION 2. Arkansas Code § 16-81-106(c)(3), concerning the authority
26	to arrest, is amended to read as follows:
27	(3) Statewide arrest powers for certified law enforcement
28	officers will be in effect only when the officer is working:
29	$\underline{(A)}$ outside Outside his or her jurisdiction at the request
30	of or with the permission of the municipal or county law enforcement agency
31	having jurisdiction in the locale where the officer is assisting or working
32	by request; or
33	(B)(i) As part of a child abduction response team.
34	(ii) As used in subdivision (c)(3)(B)(i) of this
35	section, "child abduction response team" means a multi-agency or multi-
36	jurisdictional composite of community professionals who are trained and
