## For An Act To Be Entitled

8 AN ACT CONCERNING BAIL DATA AND TRANSPARENCY; AND FOR  
9 OTHER PURPOSES.

### Subtitle

12 THE BAIL DATA AND TRANSPARENCY ACT.

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17  
18 SECTION 1. DO NOT CODIFY. Legislative findings.

19 The General Assembly finds that:

20 (1) The implementation of a uniform data collection system  
21 regarding bail to better understand how bail is employed throughout the state  
22 is an important state interest;

23 (2) The public has the right to transparent information  
24 regarding the use of bail throughout the state;

25 (3) Based on the most recently available data from the  
26 Association of Arkansas Counties and the Prison Policy Initiative, Arkansas  
27 spends approximately one hundred million dollars (\$100,000,000) per year to  
28 house detainees in local jails; and

29 (4) Seeking opportunities to reduce financial expenditures and  
30 unnecessary government services while improving public safety and the  
31 integrity of the criminal justice system is an important state interest; and

33 SECTION 2. Arkansas Code Title 16, Chapter 84, Subchapter 1, is  
34 amended to add an additional section to read as follows:

35 16-84-117. Bail bond data and transparency.

36 (a) As used in this section:



1           (1) "Participating court" means a court that uses the uniform  
2 case management software promulgated by the Administrative Office of the  
3 Courts; and

4           (2) "Person" means a person who is or has been incarcerated or  
5 detained in a county jail, local detention facility, or regional detention  
6 facility.

7           (b) The office shall establish a uniform data collection system to  
8 collect data regarding each setting and modification of bail from every  
9 participating court.

10          (c) A court that uses the office's case management software system  
11 shall collect and remit to the office the following data regarding every  
12 person:

13           (1) Any arrest date, any bail hearing date, any date the person  
14 is admitted to bail, and any date of bail modification;

15           (2) The person authorized to take bail, as defined under § 16-  
16 84-102, who has set or modified bail;

17           (3) Information about the person, including the person's year of  
18 birth, race, ethnicity, gender, primary language, and residential zip code;

19           (4) Information concerning whether the person is considered  
20 indigent by the court;

21           (5) Information related to the person's charges or reason for  
22 detention, including:

23                   (A) The number of charges; and

24                   (B) The most serious offense for which the person is  
25 charged and a general description and classification of the offense;

26           (6) Information concerning whether the person is admitted to  
27 bail or whether the bail has been modified;

28           (7) Information related to the conditions of bail and the bond  
29 for the person, including without limitation:

30                   (A) Whether the bond was secured or unsecured;

31                   (B) The monetary amount set on the bond, including the  
32 amount set on both secured and unsecured bonds;

33                   (C) Initial nonmonetary conditions of release imposed;

34                   (D) Subsequent modifications of the bail;

35                   (E) The total amount of money paid on the bond; and

36                   (F) Whether the person utilized the services of a

1 professional bail bondsman;

2 (8) If an person is not admitted to bail, the reason for the  
3 denial;

4 (9) If the person has any known outstanding arrest warrants or  
5 other holds that are an impediment to his or her release from custody placed  
6 on him or her from another jurisdiction, including a detention hold from the  
7 United States Immigration and Customs Enforcement or other detention hold  
8 from another jurisdiction;

9 (10) Any date where a person failed to appear for a court  
10 hearing;

11 (11) Any date of any revocation of bail due to a violation of  
12 the person's conditions of release, failure to appear for a court hearing, or  
13 the commission of a new offense by the person, and the reason for revocation;

14 (12) The date the person is sentenced to prison, if applicable,  
15 and any date the person begins serving his or her term in prison;

16 (13) The date the person is released or discharged from custody,  
17 including release upon satisfaction of the terms of any recognizance, release  
18 upon the disposition of any charges, or release upon completion of sentence;

19 (14) The reason for a release or discharge of the person from  
20 custody of the correctional facility; and

21 (15) The average cost per night to house the person in the  
22 correctional facility where the person is detained or, if released, where the  
23 person would be detained but for release.

24 (d)(1) The office shall submit a quarterly report compiling the data  
25 received under this section to the Legislative Council.

26 (2) The report under this subsection shall not identify a person  
27 by name and shall disaggregate data by person and sentencing court.

28 (e) The office may promulgate rules as necessary to implement this  
29 section.

30  
31 SECTION 3. DO NOT CODIFY. Temporary legislation.

32 (a) The first report required under § 16-84-117(c) shall be made on or  
33 before January 1, 2020.

34 (b) The uniform data collection system required under this act shall  
35 be operational on or before October 1, 2019.
