22	SECTION 1. Arkansas Code § 7-7-203(f), concerning dates for	
23	certifications to political parties, is amended to read as follows:	
24	(f) The county convention of a political party holding a primary	
25	election shall be held on the first Monday following the date of the general	1
26	primary election:	
27	(1) No sooner than the day after the general primary election:	<u>is</u>
28	held or, if no general primary election is held, no sooner than the day after	<u>er</u>
29	the preferential primary election is held; and	
30	(2) No later than one hundred (100) days before the general	
31	election.

33	SECTION 2. Arkansas Code § 7-7-203(g)(1), concerning dates for	
34	certifications to political parties, is amended to read as follows:	
35	(g)(1) $\underline{(A)}$ The county board of election commissioners shall certify to	0
36	the county clerk and the county committee a list of all nominated candidate	s

1	who received the most votes or are unopposed on the ballot for county,
2	township, and municipal offices, and the political parties' county committee
3	members and delegates.
4	(B) The list under subdivision (g)(1)(A) shall be provided
5	no later than:
6	(i) Ten (10) days after certification of the:
7	(a) General primary election; or
8	(b) If no general primary election will be
9	held, the preferential primary election; and
10	(ii) One hundred (100) days before the general
11	election.

13	SECTION 3. Arkansas Code § 7-7-203(h)(2)(B)(i), concerning
14	certification of lists of nominated candidates by the political parties, is
15	amended to read as follows:
16	(B)(i) Each county political party committee shall issue
17	the certified list on behalf of those nominated candidates and submit the
18	certified list to the county clerk and county board of election commissioners
19	at least ninety (90) days before the general election.
20	
21	SECTION 4. Arkansas Code § 7-7-402(a)(2), concerning filing of
22	certified lists of nominees for county, township and municipal offices, is
23	amended to read as follows:
24	(2) All certified lists of nominees for county, township, and
25	municipal offices shall be filed with the county board of election
26	commissioners and the county clerk of the county in which they are to be
27	voted for no later than ninety (90) days before the general election.
