23	TO CONTINUE THE LEVY OF A ONE-HALF

29	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL
30	ASSEMBLY OF THE STATE OF ARKANSAS, AND BY THE SENATE, A MAJORITY OF ALL
31	MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:

33	That the following is proposed as an amendment to the Constitution of
34	the State of Arkansas, and upon being submitted to the electors of the state
35	for approval or rejection at the next general election for Representatives
36	and Senators, if a majority of the electors voting thereon at the election



1	adopt the amendment, the amendment shall become a part of the Constitution of
2	the State of Arkansas, to wit:

4	SECTION 1. The Arkansas Constitution is amended to read as follows:
5	<u>§ 1. Intent of amendment.</u>
6	(a) Arkansas Constitution, Amendment 91, levies a one-half percent
7	sales and use tax to provide additional funding for the state's four-lane
8	highway system, county roads, and city streets.
9	(b) The one-half percent sales and use tax under Arkansas
10	Constitution, Amendment 91, shall be abolished when there are no bonds
11	outstanding to which tax collections are pledged as provided in this
12	amendment.
13	(c) Notwithstanding Arkansas Constitution, Amendment 91, § 8, it is
14	the intent of this amendment that the sales and use tax levied under Arkansas
15	Constitution, Amendment 91, continue after the retirement of the bonds
16	authorized in Arkansas Constitution, Amendment 91, to provide special revenue
17	for use of maintaining, repairing, and improving the state's system of
18	highways, county roads, and city streets.
19	
20	§ 2. Excise tax.
21	(a)(l) Except for food and food ingredients, an additional excise tax
22	of one-half percent (0.5%) is levied on all taxable sales of tangible
23	personal property, specified digital products, a digital code, and services
24	subject to the tax levied by the Arkansas Gross Receipts Act of 1941,
25	Arkansas Code § 26-52-101 et seq.
26	(2) The tax shall be collected, reported, and paid in the same
27	manner and at the same time as is prescribed by law for the collection,
28	reporting, and payment of all other Arkansas gross receipts taxes.
29	(b)(l) Except for food and food ingredients, an additional excise tax
30	of one-half percent (0.5%) is levied on all tangible personal property,
31	specified digital products, a digital code, and services subject to the tax
32	levied by the Arkansas Compensating Tax Act of 1949, Arkansas Code § 26-53-
33	<u>101 et seq.</u>
34	(2) The tax shall be collected, reported, and paid in the same
35	manner and at the same time as is prescribed by law for the collection,
36	reporting, and payment of Arkansas compensating taxes.

2	§ 3. Disposition of revenue.
3	(a) The revenue from the taxes levied under § 2 of this amendment
4	shall be distributed to the State Highway and Transportation Department Fund,
5	the County Aid Fund, and the Municipal Aid Fund in the percentages provided
6	in sections § 27-70-201 and § 27-70-206 of the Arkansas Highway Revenue
7	Distribution Law.
8	(b) No revenue derived from the taxes levied under § 2 of this
9	amendment shall be used to secure bonds.
10	
11	<u>§</u> 4. Effective date.
12	(a) If the Chief Fiscal Officer of the State determines that a written
13	statement under Arkansas Constitution, Amendment 91, § 8(b), has been filed
14	with the Chief Fiscal Officer of the State before June 1, 2023, the tax under
15	§ 2 of this amendment shall be levied and collected on and after July 1,
16	2023.
17	(b) If a written statement under Arkansas Constitution, Amendment 91,
18	§ 8(b), has not been filed with the Chief Fiscal Officer of the State before
19	June 1, 2023, the tax under § 2 of this amendment shall not be levied and
20	collected until the first day of the first calendar quarter beginning more
21	than thirty (30) days after a written statement under Arkansas Constitution,
22	Amendment 91, § 8(b), is filed with the Chief Fiscal Officer of the State.
23	
24	SECTION 2. BALLOT TITLE AND POPULAR NAME. When this proposed
25	amendment is submitted to the electors of this state on the general election
26	<u>ballot:</u>
27	(1) The title of this Joint Resolution shall be the ballot title; and
28	(2) The popular name shall be "An Amendment to the Arkansas
29	Constitution Continuing a One-Half Percent (0.5%) Sales and Use Tax for State
30	Highways and Bridges; County Roads, Bridges and Other Surface Transportation;
31	and City Streets, Bridges, and Other Surface Transportation After the
32	Retirement of the Bonds Authorized in Arkansas Constitution, Amendment 91".
