21	WHEREAS, Alzheimer's disease, a progressive neurodegenerative
22	brain disorder, tragically robs individuals of their memories and leads
23	to progressive mental and physical impairments; and
24	
25	WHEREAS, there are no known treatments to prevent, cure, or even
26	delay the onset or slow the progression of Alzheimer's disease; and
27	
28	WHEREAS, an estimated 60,000 Arkansans have Alzheimer's disease, and
29	currently 177,000 Arkansans are designated caregivers; and
30	
31	WHEREAS, Alzheimer's disease is the 6th-leading cause of death in the
32	United States, and as of 2015, Arkansas had the 4th-highest Alzheimer's
33	mortality rate in the country; and
34	
35	WHEREAS, according to the Alzheimer's Association 2018 Alzheimer's
36	Disease Facts and Figures report, the direct costs to American society of

1 caring for those with Alzheimer's is valued at \$259 billion; more than 15 2 million caregivers provided over 18 billion hours of unpaid care for those 3 with Alzheimer's and other dementias in 2016; and in Arkansas, nearly 177,000 4 family members and friends cared for people with Alzheimer's and other 5 dementias, providing 201 million hours of unpaid care, with the annual value 6 of this caregiving totaling 2,545 million dollars; and 7 8 WHEREAS, the mission of the Alzheimer's Association is to eliminate 9 Alzheimer's disease and other dementias through the advancement of research 10 and promotion of brain health and to enhance care and support for all 11 individuals with Alzheimer's disease and their families and caregivers; and 12 13 WHEREAS, the efforts of the Alzheimer's Association to raise funds 14 and promote awareness to fight Alzheimer's disease and other dementias help 15 improve the quality of human life for those living with Alzheimer's disease 16 and their caregivers; and 17 18 WHEREAS, February 26, 2019, would be an appropriate day to establish 19 Alzheimer's Awareness Day in recognition of the individuals, families, 20 friends, and caregivers dealing with Alzheimer's disease and the researchers 21 who are seeking a cause and cure, 22 23 NOW THEREFORE, 24 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL 25 ASSEMBLY OF THE STATE OF ARKANSAS: 26 27 THAT the House of Representatives commend the Arkansas Chapter of the 28 Alzheimer's Association for their outstanding work in fighting this 29 terrible disease and advocating for those living with the disease, and 30 proclaim February 26, 2019, as Alzheimer's Awareness Day. 31 32 33 34 35 36
