9 AND OPERATING EXPENSES FOR THE DEPARTMENT OF HUMAN  
10 SERVICES - DIVISION OF CHILD CARE AND EARLY CHILDHOOD  
11 EDUCATION FOR THE FISCAL YEAR ENDING JUNE 30, 2020;  
12 AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT FOR THE DEPARTMENT OF HUMAN  
16 SERVICES - DIVISION OF CHILD CARE AND  
17 EARLY CHILDHOOD EDUCATION APPROPRIATION  
18 FOR THE 2019-2020 FISCAL YEAR.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
25 for the Department of Human Services - Division of Child Care and Early  
26 Childhood Education for the 2019-2020 fiscal year, the following maximum  
27 number of regular employees.

31 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for  
 32 the Department of Human Services - Division of Child Care and Early Childhood  
 33 Education for the 2019-2020 fiscal year, the following maximum number of  
 34 part-time or temporary employees, to be known as "Extra Help", payable from  
 35 funds appropriated herein for such purposes: thirteen (13) temporary or  
 36 part-time employees, when needed, at rates of pay not to exceed those

1 provided in the Uniform Classification and Compensation Act, or its  
 2 successor, or this act for the appropriate classification.

 4 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 5 to the Department of Human Services - Division of Child Care and Early  
 6 Childhood Education, to be payable from the paying account as determined by  
 7 the Chief Fiscal Officer of the State, for personal services and operating  
 8 expenses of the Department of Human Services - Division of Child Care and  
 9 Early Childhood Education for the fiscal year ending June 30, 2020, the

9        *SECTION 8. APPROPRIATION - SAVE THE CHILDREN. There is hereby*

10 *appropriated, to the Department of Human Services - Division of Child Care*

11 *and Early Childhood Education, to be payable from the paying account as*

12 *determined by the Chief Fiscal Officer of the State, for a grant for*

13 *statewide after school literacy, nutrition, home visiting and early childhood*

14 *programs to be administered by Save the Children for low income, at-risk*

15 *children in a sum not to exceed .....\$2,000,000.*

17        SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

18 authorized by this act shall be limited to the appropriation for such agency

19 and funds made available by law for the support of such appropriations; and

20 the restrictions of the State Procurement Law, the General Accounting and

21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

22 Procedures and Restrictions Act, or their successors, and other fiscal

23 control laws of this State, where applicable, and regulations promulgated by

24 the Department of Finance and Administration, as authorized by law, shall be

25 strictly complied with in disbursement of said funds.

26

27        SECTION 10. LEGISLATIVE INTENT. It is the intent of the General

28 Assembly that any funds disbursed under the authority of the appropriations

29 contained in this act shall be in compliance with the stated reasons for

30 which this act was adopted, as evidenced by the Agency Requests, Executive

31 Recommendations and Legislative Recommendations contained in the budget

32 manuals prepared by the Department of Finance and Administration, letters, or

33 summarized oral testimony in the official minutes of the Arkansas Legislative

34 Council or Joint Budget Committee which relate to its passage and adoption.

36        SECTION 11. EMERGENCY CLAUSE. It is found and determined by the

1 General Assembly, that the Constitution of the State of Arkansas prohibits  
2 the appropriation of funds for more than a one (1) year period; that the  
3 effectiveness of this Act on July 1, 2019 is essential to the operation of  
4 the agency for which the appropriations in this Act are provided, and that in  
5 the event of an extension of the legislative session, the delay in the  
6 effective date of this Act beyond July 1, 2019 could work irreparable harm  
7 upon the proper administration and provision of essential governmental  
8 programs. Therefore, an emergency is hereby declared to exist and this Act  
9 being necessary for the immediate preservation of the public peace, health  
10 and safety shall be in full force and effect from and after July 1, 2019.
