21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code § 14-44-109(a), concerning certain elected
24	positions in a city of the second class, is amended to read as follows:
25	(a) $(1)(A)$ At the time prescribed in this subtitle, the qualified
26	voters of each city of the second class shall elect a city marshal, \underline{a} city
27	recorder, and \underline{a} city treasurer.
28	(B) Each of these officers city marshal, city recorder, or
29	<pre>city treasurer shall continue in office until his or her successor is elected</pre>
30	and qualified.
31	(2)(A) The city council may provide by ordinance for the
32	appointment of the city treasurer.
33	(B) An ordinance under subdivision (a)(2)(A) of this
34	section shall be passed before the filing period begins for an election for
35	the office of city treasurer, but no later than the February preceding the
36	beginning of the early filing period.

T	SECTION 2. Arkansas Code § 14-44-115 is amended to read as follows:
2	14-44-115. Election of recorder, treasurer, or recorder-treasurer.
3	(a) On the Tuesday following the first Monday in November, 1972, and
4	every four (4) years thereafter, the qualified voters of cities of the second
5	class shall elect a recorder, a treasurer, or a recorder-treasurer, as the
6	case may be, for a term of four (4) years.
7	(b)(1) The city council may provide by ordinance for the appointment
8	of the city treasurer.
9	(2) An ordinance under subdivision (b)(1) of this section shall
10	be passed before the filing period begins for an election for the office of
11	city treasurer, but no later than the February preceding the beginning of the
12	early filing period.
13	
14	SECTION 3. Arkansas Code § 14-45-108 is amended to read as follows:
15	14-45-108. Election of recorder-treasurer.
16	(a) The qualified voters of incorporated towns shall elect one (1)
17	recorder-treasurer on the Tuesday following the first Monday in November 1982
18	and every four (4) years thereafter.
19	(b)(l)(A) The town council may provide by ordinance for the
20	appointment of the town recorder-treasurer.
21	(B) An ordinance under subdivision (b)(1)(A) of this
22	section shall be passed before the filing period begins for an election for
23	the office of town recorder-treasurer, but no later than the February
24	preceding the beginning of the early filing period.
25	(2) A town recorder-treasurer appointed under subdivision
26	(b)(l)(A) of this section shall not administer the oath of office under § 14-
27	<u>42-106 or § 21-2-105.</u>
