26	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

28 29	SECTION 1. Arkansas Code § 11-4-203(3), concerning exclusions from the definition of "employee" under the Minimum Wage Act of the State of Arkansas,
30	is amended to add additional subdivisions to read as follows:
31	(S) An individual under eighteen (18) years of age; or
32	(T) An individual who has been convicted of a felony.
33	(1) An individual who has been convicted of a felony.
34	SECTION 2. Arkansas Code § 11-4-203(4)(B), concerning the definition
35	of "employer" under the Minimum Wage Act of the State of Arkansas, is amended
36	to read as follows:

1	(B) "Employer" <del>shall</del> <u>does</u> not include <del>any</del> <u>an</u> individual,
2	partnership, association, corporation, business trust, nonprofit
3	organization, or any person or group of persons acting directly or indirectly
4	in the interest of an employer in relation to an employee for any work week
5	in which fewer than four (4) twenty-five (25) employees are employed;

7	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
8	General Assembly of the State of Arkansas that delay in implementation of
9	this act would cause disruption in the business market and that a need exists
10	for consistency in the implementation of the Minimum Wage Act of the State of
11	Arkansas, § 11-4-201 et seq. Therefore, an emergency is declared to exist,
12	and this act being immediately necessary for the preservation of the public
13	peace, health, and safety shall become effective on:
14	(1) The date of its approval by the Governor;
15	(2) If the bill is neither approved nor vetoed by the Governor,
16	the expiration of the period of time during which the Governor may veto the
17	bill; or
18	(3) If the bill is vetoed by the Governor and the veto is
19	overridden, the date the last house overrides the veto.
