28	(a) The General Assembly finds that:			
2 9	(1) Henderson State University and College of T	he Ouachitas are		
30	two institutions of Higher Education with a long history of a	cooperation and		
31	mutual support for the pursuit of their missions to serve the residents of			
32	their overlapping service areas;			
33	(2) These institutions have entered into a memor	randum of		
34	understanding (the MOU) to continue the goodwill that has been	en established		
35	between them and throughout the communities they serve, and	to enhance the		
36	level of services to the residents of Clark County without de	uplicating		

1 efforts; and

2 (3) Working strategically, the institutions can meet the needs 3 of the residents of Clark County in a manner that fosters partnership and 4 collaboration.

5 (b) Based upon the agreement of the parties, the two institutions will work 6 collaboratively within the framework of the MOU for the betterment of 7 students in their service areas.

8 The provisions of this section shall be in effect only from July 1, 2018 9 2019 through June 30, 2019 2020.

11 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 12 authorized by this act shall be limited to the appropriation for such agency 13 and funds made available by law for the support of such appropriations; and 14 the restrictions of the State Procurement Law, the General Accounting and 15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education Expenditures 16 17 Restrictions Act, or their successors, and other fiscal control laws of this 18 State, where applicable, and regulations promulgated by the Department of 19 Finance and Administration, as authorized by law, shall be strictly complied 20 with in disbursement of said funds.

21

22 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General 23 Assembly that any funds disbursed under the authority of the appropriations 24 contained in this act shall be in compliance with the stated reasons for 25 which this act was adopted, as evidenced by the Agency Requests, Executive 26 Recommendations and Legislative Recommendations contained in the budget 27 manuals prepared by the Department of Finance and Administration, letters, or 28 summarized oral testimony in the official minutes of the Arkansas Legislative 29 Council or Joint Budget Committee which relate to its passage and adoption. 30

31 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General 32 Assembly, that the Constitution of the State of Arkansas prohibits the 33 appropriation of funds for more than a one (1) year period; that the 34 effectiveness of this Act on July 1, 2019 is essential to the operation of 35 the agency for which the appropriations in this Act are provided, and that in 36

the event of an extension of the legislative session, the delay in the
