## For An Act To Be Entitled

9 AN ACT CONCERNING THE FEE TO ATTEND A VICTIM IMPACT  
10 PANEL THAT IS REQUIRED BY LAW OF ANY PERSON CONVICTED  
11 OF DRIVING OR BOATING WHILE INTOXICATED, REFUSAL TO  
12 SUBMIT TO A CHEMICAL TEST, OR POSSESSION OF ALCOHOL  
13 BY A MINOR; AND FOR OTHER PURPOSES.

## Subtitle

16 CONCERNING THE FEE TO ATTEND A VICTIM  
17 IMPACT PANEL THAT IS REQUIRED BY LAW OF  
18 ANY PERSON CONVICTED OF DRIVING OR  
19 BOATING WHILE INTOXICATED, REFUSAL TO  
20 SUBMIT TO A CHEMICAL TEST, OR POSSESSION  
21 OF ALCOHOL BY A MINOR.

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
26

27 SECTION 1. Arkansas Code § 5-65-121 is amended to read as follows:  
28 5-65-121. Victim impact panel attendance – Fee.

29 (a)(1) A person whose driving privileges are suspended or revoked for  
30 violating § 5-65-103, § 5-65-205, § 5-65-303, § 5-65-310, or § 3-3-203 shall  
31 attend a victim impact panel sponsored by an organization approved by the  
32 Division of Aging, Adult, and Behavioral Health Services of the Department of  
33 Human Services.

34 (2) The organization selected by the division shall be an  
35 organization that provides statewide services to victims of drunk driving.

36 (b)(1) ~~The~~ To offset the costs of the program, the organization



1 approved by the division may collect a program fee of ~~ten~~:

2 (A) Ten dollars (\$10.00) per enrollee who resides at the  
3 time in a facility operated by the Department of Community Correction; or

4 (B) Twenty dollars (\$20.00) per enrollee ~~to offset program~~  
5 ~~costs to be remitted to the organization for all other enrollees.~~

6 (2) The organization approved by the division shall provide  
7 proof of attendance and completion to the person required to attend the  
8 victim impact panel upon completion of the victim impact panel.

9 (3) Program fees collected under this section shall be remitted  
10 to the organization approved under this section.
