19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21	SECTION 1. Arkansas Code § 5-54-133 is amended to read as follows:	
22	5-54-133. Improper use of or altering the state seal.	
23	(a) As used in this section, "state seal":	
24	(1) "Campaign" means:	
25	(A) A campaign of a candidate for public office;	
26	(B) Efforts to support or oppose a candidate for electe	<u>:d</u>
27	office; or	
28	(C) Efforts to support or oppose a ballot measure excep	<u>t</u>
29	as provided in § 7-1-111;	
30	(2) "Electronic campaign material" includes without limitation	<u>n</u>
31	the following item used in a campaign:	
32	(A) An advertisement;	
33	(B) A commercial;	
34	(C) A photograph;	
35	(D) An electronic communication; and	
36	(E) A social media post;	

T	(3) "Printed campaign material" includes without limitation the

3	(A) A sign;

7	(4) "State seal" means the Seal of the State of Arkansas

9	(b) A person commits improper use of or altering the state seal if the
10	person knowingly uses the state seal or an altered version of the state seal $\underline{:}$
11	$\underline{(1)}$ in $\underline{\text{In}}$ a private, nongovernmental written communication to
12	another person with the purpose to injure, defraud, harass, intimidate, or
13	coerce the other person, and the actor:
14	(1)(A) Assumes a false identity;
15	$\frac{(2)}{(B)}$ Pretends to be a representative of a state or local
16	agency;
17	$\frac{(3)}{(0)}$ Pretends to be an officer or employee of the
18	government; or
19	$\frac{(4)}{(D)}$ Attempts to collect a debt the actor contends is
20	owed to the actor or another person or organization+; or
21	(2) On printed campaign material or electronic campaign material
22	in a manner that would lead a reasonable person to believe that the printed
23	campaign material or electronic campaign material delivered to, disseminated
24	to, or otherwise seen by the person is an official document of the State of
25	Arkansas.
26	(c) Improper use of or altering the state seal is a Class A
27	misdemeanor.
28	(d) A prosecution under this section does not preclude a prosecution
29	or civil action under § 4-88-101 et seq.
