## For An Act To Be Entitled

AN ACT TO AMEND THE LAW CONCERNING THE DEPOSIT AND  
DISTRIBUTION OF FEES TO THE DEPARTMENT OF ARKANSAS  
STATE POLICE FUND; AND FOR OTHER PURPOSES.

## Subtitle

TO AMEND THE LAW CONCERNING THE DEPOSIT  
AND DISTRIBUTION OF FEES TO THE  
DEPARTMENT OF ARKANSAS STATE POLICE FUND.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 19-6-301, concerning special revenues  
enumerated, is amended to add an additional subdivision to read as follows:  
(263) Driving record information fees collected under § 27-23-  
117.

SECTION 2. Arkansas Code § 19-6-404(1), concerning the Department of  
Arkansas State Police Fund, is amended to read as follows:

(1) Those special revenues as specified in § 19-6-301(1), (5),  
(7), (8), (38)-(40), (94), (150), (168), (175), (184)-(186), (190), (218)-  
(220), (222), (226), (227), (234), ~~and (252)~~, and (263);

SECTION 3. Arkansas Code § 27-23-117(3), concerning the distribution  
of a driving record, is amended to read as follows:

(3) To others, authorized to receive the information pursuant to  
§ 27-50-906, upon request and payment of a fee of ~~seven dollars (\$7.00)~~ eight



1 dollars and fifty cents (\$8.50).

3 SECTION 4. Arkansas Code § 27-23-118(c), concerning the deposit and  
4 distribution of the driving record fee is amended to read as follows:

5 (c) The fee set out in § 27-23-117(3) shall be deposited as special  
6 revenues into the State Treasury and distributed as follows:

7 (1) One dollar (\$1.00) of the fee shall be deposited to the  
8 credit of the Revenue Division of the Department of Finance and  
9 Administration in the Commercial Driver License Fund; ~~and~~

10 (2) ~~The remaining six~~ Six dollars (\$6.00) of the fee shall be  
11 deposited to the credit of the State Highway and Transportation Department  
12 Fund for distribution as provided in the Arkansas Highway Revenue  
13 Distribution Law, § 27-70-201 et seq.; and

14 (3) The remaining one dollar and fifty cents (\$1.50) of the fee  
15 shall be deposited to the credit of the Department of Arkansas State Police  
16 Fund.
